APPROVE A RESOLUTION TO CONTRACT WITH AND ACCEPT GRANT FUNDS FROM THE CALIFORNIA DEPARTMENT OF HEALTH SERVICES, STD CONTROL BRANCH FOR COMMUNICABLE DISEASE CONTROL AND PREVENTION.

WHEREAS, Plumas County Public Health Agency has placed a high priority on communicable disease control; and

WHEREAS, PCPHA will conduct a sexually transmitted disease (STD) Prevention and control program incorporating education, awareness, outreach, counseling, testing, treatment, surveillance, reporting and/or partner services with special emphasis on individuals at high risk for Chlamydia, gonorrhea and/or infectious syphilis;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors, County of Plumas, State of California strongly, supports Plumas County Public Health Agency work with the California Department of Health Services, STD Control Branch for communicable disease control in Plumas County, California; the Board of Supervisors authorizes the Director of Public Health to sign as the Boards designee.

BE IT FURTHER RESOLVED that the Plumas County Public Health Agency intends to work as the lead organization to develop and implement this Project.




