In your e-mail dated November 7, 2011, you expressed Plumas Rural Services' desire to withdraw interest in Contracts CDCI 1112 PRS and DCP 1112 PRS for the purpose of providing substance use disorder treatment services to Drug Court Program clients.

The Drug Court Program is not interested in an extension of the current bridge contract, which ended September 30, 2011. As stated in my e-mail to you on November 14, 2011, The Community Corrections Partnership did not recommend an extension of the terms of the bridge contract with PRS, and instead passed a motion directing the County to issue a Request For Proposals for treatment services for the Drug Court Program.

It is regrettable that PRS and Plumas County were unable to reach an agreement for services beyond September 30, 2011. Please return the contract forms that the County had signed and submitted to PRS. Whether or not the forms are returned, they shall be considered of no further force or effect.
