

**RESOLUTION TO AMEND THE PLUMAS COUNTY POSITION ALLOCATION FOR  
BUDGET YEAR 2009-2010**

**WHEREAS**, the Board of Supervisors, through adoption of the budget allocates positions for the various county departments each fiscal year; and

**WHEREAS**, during the fiscal year the Board of Supervisors may amend the position allocation by resolution; and

**WHEREAS**, to comply with new requirements for grants received for fiscal year 2009-2010 for Public Health Emergency Preparedness and Public Health Emergency Response it is necessary that a new fund 0015P be established; and

**WHEREAS**, with this new fund 0015P there will also be four new departments 70561 CDC Base/Pan Flue, 70566 HPP, 70567 H1N1 HPP, and 70568 PHER; and

**WHEREAS**, the changes to the Position Allocation will remove FTE's from the current Health Department 70560 and allocate these same FTE's to the various new departments. Therefore, there is zero increase to the overall Position Allocation for 2009-2010 by this action.

**NOW, THEREFORE, BE IT RESOLVED** by the Plumas County Board of Supervisors as follows:


