

**RESOLUTION TO AMEND THE PLUMAS COUNTY POSITION ALLOCATION FOR BUDGET YEAR 2010-2011 WITHIN THE DEPARTMENTS OF DISTRICT ATTORNEY/CRIMINAL, DISTRICT ATTORNEY/OCJP-ADA AND DA/SRVP GRANT**

**WHEREAS**, the Board of Supervisors, through adoption of the budget allocates positions for the various county departments each fiscal year; and

**WHEREAS**, during the fiscal year the Board of Supervisors may amend the position allocation by resolution; and

**WHEREAS**, the District Attorney, David Hollister has informed the Board of Supervisors that the grant funding for the DA/SRVP GRANT ended last fiscal year; and

**WHEREAS**, though the Department has continued to fund the position of Family Violence Officer it can no longer afford to continue to do so; and

**WHEREAS**, due to the funding shortage, and the decision by the Board not to utilize General fund contingencies to continue this position, the Board of Supervisors hereby approves the layoff of the Family Violence Officer, and directs staff to issue the 30 day notice of layoff; and

**WHEREAS**, due to the layoff of the Family Violence Officer it is necessary to amend the Position Allocation by removing 0.44 FTE Family Violence Officer, District Attorney/Criminal-70301, 0.10 FTE Family Violence Officer, District Attorney/OCJP ADA – 70302 and 0.46 FTE Family Violence Officer, DA/SRVP Grant.

**NOW, THEREFORE, BE IT RESOLVED** by the Plumas County Board of Supervisors as follows:

1. Approve the layoff of the Family Violence Officer, and direct staff to issue layoff notice.
2. Approve the amendment to the Position Allocation for budget year 2010/2011 to reflect the following as of April 8, 2011:




