(37) Post procedures for sanitizing 3-compartment sink prior to washing vegetables. ~~Include that no dga~~
Includes: Wash and sanitize with 100ppm bleach soln.
No dishwashing or dirty dishes in sink


(38) Thoroughly clean hood and filters to remove grease and residue.

(40) No chlorine in sanitizer buckets. Maintain at 100ppm chlorine. Corrected at time of inspection.

(45) Thoroughly clean floors and equipment in back prep room to remove flour residue. Clean ~~dirty~~ regularly dga to prevent build-up of flour residue.
