#### **SPECIAL DISTRICTS GOVERNED BY BOARD OF SUPERVISORS**

The Board of Supervisors sits as the Governing Board for various special districts in Plumas County including Dixie Valley Community Services District; Walker Ranch Community Services District; Grizzly Ranch Community Services District; Beckwourth County Service Area; Plumas County Flood Control and Water Conservation District; Quincy Lighting District; Crescent Mills Lighting District.

#### **1. FLOOD CONTROL AND WATER CONSERVATION DISTRICT MONTEREY SETTLEMENT AGREEMENT/PLUMAS WATERSHED FORUM**

Report and update by Brian Morris, General Manager on Monterey Settlement Agreement and Plumas Watershed Forum.

#### **PORTOLA PRESSURE REDUCING AND FLOW CONTROL STATION**

This matter is before the Board for approval of Change Order No. 2 with Wilburn Construction for work on the Portola pressure reducing and flow control station.

Public Works staff is reviewing the change order to determine whether it is the best way to proceed or whether there may be more cost-effective options.

### **REGIONAL WATER PLAN/GENERAL PLAN WATER ELEMENT**

Presentation by Brian Morris, General Manager regarding the Regional Water Plan Update and relation to Plumas County General Plan water element. Many of the issues that would be addressed in a typical water element are also required to be addressed in the Integrated Regional Water Management (IRWM) plan. Discussions with the Planning Commission include 1) a decision on whether there will be a stand-alone water element or whether water issues will be incorporated in other elements; 2) decisions of the overall format and level of detail for the General Plan; and 3) additional public input, including the public workgroup process that is just beginning.

The Board concurs the water element is a very important piece of the General Plan. There is discussion regarding groundwater monitoring and the importance of adopting a groundwater protection ordinance.

Grieze, owner/applicant subject to conditions of approval and findings as recommended by Planning and as follows. AYES: Supervisors Swofford, Simpson, Meacher, Olsen and Thrall NOES: None ABSENT: None Carried and so ordered

- A) There are special circumstances applicable to the property under which strict application of the provisions of this chapter would deprive the property owner of privileges enjoyed by other property owners in the vicinity.
- B) These special circumstances do not apply generally to other properties in the same zone.
- C) The variance is necessary for the preservation and enjoyment of the substantial property rights of the applicant.
- D) The granting of the variance would not result in material damage or prejudice to other properties in the vicinity nor be detrimental to the public health, safety and general welfare.
- E) The proposed construction is consistent with the existing General Plan because the Prime Opportunity area standards are met and the density is not exceeded. There is a reasonable probability that the project will be consistent with the future adopted general plan because it is unlikely that residential building standards will be changed.
- F) There is little or no probability that the project will be detrimental to or interfere with the future adopted general plan because of the existing development on the property.
