**Project Title:** Graeagle-Johnsville Road Rehabilitation Project

**Project Applicant:** Plumas County Department of Public Works

**Project Location:** The project area encompasses 39.56 acres and consists of a linear alignment running approximately 3.4 miles along Graeagle-Johnsville Road in Plumas County, California. It is shown on the *Johnsville, California* 7.5-minute U.S. Geological Survey quadrangle in Township 22 North, Range 11 East, Section 24. The approximate location of the eastern end of the project is at latitude 39.781475°, longitude -120.648426° and the approximate location of the western end of the project is at latitude 39.757420°, longitude -120.697382° (North American Datum 83)

**Description of Nature, Purpose or Beneficiaries of Project:** The County proposes to repair the two-lane county road (County Road 506) between mile posts (MP) 1.82 and 5.15 (Figure 2). Key project components to maintain the integrity of Graeagle-Johnsville Road include the following: 1) Repair slide and bank failure, 2) Improve the culvert crossing Graeagle-Johnsville Road near the Plumas-Eureka State Park, and 3) Construct an asphalt/concrete overlay of the existing pavement between MP 1.85 and 5.15 to increase the life of the roadway.
