STANDING ORDERS

Due to the Coronavirus disease (COVID-19) Public Health Emergency, dated March 16, 2020, the County of Plumas is making several changes related to Planning Commission meetings to protect the public's health and prevent the disease from spreading locally. Plumas County Health Officer Recommendation Regarding Teleconferencing, issued on September 30, 2021, recommends local legislative bodies, such as commission, committees, boards, and council, hold public meetings with teleconferencing as authorized by Government Code section 54953 (e). Pursuant to Government Code section 54953 (e) and to maintain the orderly conduct of the meeting, the County of Plumas members of the Planning Commission may attend the meeting via teleconference or phone conference and participate in the meeting to the same extent as if they were physically present. Due Government Code section 54953(e), the Boardroom will be open to the public but subject to social distancing requirements. Those that wish to attend the Board meeting, will be required to wear a face covering, as required by the local Public Health Officer order.

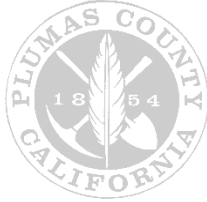



Plumas County is required to submit an annual report on the status of the General Plan and progress in its implementation per Government Code Section 65400. The General Plan Annual Progress Report is due on April 1, 2022 and covers the 2021 calendar year. Commissioners to discuss and take possible action to recommend the Report be forwarded to the Board of Supervisors. (Tracey Ferguson, AICP, Planning Director and Tim Evans, Senior Planner).

1. Page 7 (4th paragraph): revise number of multi-family units and total units lost to demolition, fire, or natural disaster to reflect numbers in Appendix B, California Department of Finance (DOF), Demographic Research Unit, Housing Unit Change Form.
2. Page 7 (add 5th paragraph): revise to include 2021 wildfires narrative explaining why there was a substantial number of units lost to demolition, fire, or natural disaster.
3. Page 7 (footnote): revise to read "Based on 2020¹ HCD Income Limits."
4. Page 10 (2021 Significant Plans and Projects): revise to include narrative for each plan/project listed.
5. Page 15 (Plumas County Code, Title 9 Review): revise top five (5) Planning staff priorities and list of additional remaining Title 9 amendments as follows:
 - A. Move #2, "Update Title 8 (Building Regulations), Chapter 17 (Flood) of Plumas County Code," to #1.
 - B. Move "Accessory Dwelling Units" from "additional remaining Title 9 amendments" to #2.

- C. Move “Electrical vehicle charging stations (AB 1326)” from “additional remaining Title 9 (Planning and Zoning) amendments” to #3.
 - D. Keep #4 as Noise Ordinance.
 - E. Move #3, “Subdivision Ordinance,” to #5.
 - F. Move “Surface Mining and Reclamation Act (SMARA) update” and “Dark sky lighting ordinance development” down to “additional remaining Title 9 (Planning and Zoning) amendments”
