3. **Behavioral Health Department**
 - a. Director's Report (Dr. Tony Hobson) – Re: grant through MH student services act – the amount rewarded was \$1.79 million (not the amount stated at last month's meeting). This has gone through county counsel. It will be presented to PC Board of Supervisors on March 8th. They will work with K-12 teachers on how best to help the kids. Bids have been received on RFPs re: teletherapy for schools and clinic. All staff are back in office (after COVID exposures). There will be a cultural competency meeting tomorrow, 3/3/22, by Zoom. The Wellness Center in downtown Quincy is getting close to move-in date. They plan to do an open house.

b. Quality Assurance Improvement (Jessica M.) – EQRO quality review will be in April. Triennial review scheduled for May 17th – 18th. Received BHIN re: use of MHSA funds for Prevention and Early Intervention programs. Received a new BHIN for COVID but it will change as state rules change. Received many draft BHIN notices.

Current stats: 337 open charts (increase of 10% from January). 82 unduplicated youth, 143 unduplicated adults. 50 new intakes in January, 34 in February. 30 crisis services in January, 24 in February. 3 hospitalizations in January. No grievances filed.
