Dear Honorable Chair and Supervisors,

We are writing today to urge each of you to please vote "No" on the upcoming board action item of the sale of Dame Shirley Plaza by Plumas County to the State of CA Judicial Council for the purpose of building a new county courthouse. We have lived in Quincy since 2001 and in downtown Quincy for the last 17 years. We love the walkability of the downtown district and its unique green space which Dame Shirley Plaza affords to the community and town visitors. We're opposed to the sale and to the State's plans for a new courthouse at that location for various reasons, including multiple negative impacts their project will bring to the downtown area, most significantly, the loss of one of only two public green spaces in town.

We strongly urge the County to sell at fair market value or to donate the property to a local community-oriented, non-profit group, such as the Feather River Land Trust or Plumas Arts, who may develop the lot in a way that will promote greater community use of the space, for example, by bringing in park infrastructure, such as permanent restrooms and the proposed Quincy Outdoor Theater.

We thank you for your time and consideration of this request and for your dedication and hard work on behalf of Plumas County.

As a resident of Quincy I believe that the foresight shown by the BOS 20 years when they purchased the land now known as DSP, for the express purpose of making sure the new courthouse would remain downtown, should be applauded. Ever since the majority of the county offices were moved out to the old hospital site downtown Quincy has been slowly dying. Building the new courthouse elsewhere will be the end of downtown in my opinion and I strongly oppose it.

The notion that DSP is the only green space downtown is ridiculous, events like Sparkle and Groundhog Fever have been held on the Courthouse lawn for years, DSP sits vacant and unused 99% of the time.

Dear Plumas County Supervisors,

I am writing to express my interest in working to make DSP an economic asset to Quincy and to our county. I am counting on you to vote NOT to sell this valuable irreplaceable asset to the State of Calif.

I have written previously sending summaries and links to mounds of research on revitalization that deem downtown parks, historic appeal, and community engagement, a sense of attachment to place as essential elements to economic recovery for struggling towns. Much of this research was aimed at small rural towns. All these elements will either be lost or severely damaged if a court building goes on the plaza.

I also sent summaries and to links to data on the negative economic impact the process of construction has on the several surrounding blocks.

Today I offer this, a step into the future when DSP is a PARK is realizing its potential as an economic asset to our town and county. Aside from staging events to draw people from outside our county, the parking area could be the site for EV chargers!

Having EV chargers in our downtown would serve several functions:

- 1) During the hours the car is charging the owners would be free to eat and explore our downtown
- 2) People with EV vehicles would be more likely to come to Quincy. Currently we have no EV chargers for the public.
- 3) Plumas County could begin migrating towards using electric vehicles which would be a cost saving after the initial investment.

Electric Vehicles are the way of our future, it is unavoidable, let's get on with installation while there are great incentives to do so:

We can do it at DSP Parking lot if the Parking lot is not designated as part of the park but as a county parking lot:

EV chargers have been installed on California County lands before. There are two rebate programs for the purchase and installation of EV chargers. The first is called the California Electric Vehicle Infrastructure Project (CALeVIP) 2.0 and offers rebates for the purchase and installation of DC fast chargers at eligible site types. Unfortunately, parks are not currently an eligible site type, (so, the property for the park would need to be separated from the parking area to qualify for this one). More information on this rebate program can be found [Here](#). The project's Implementation Manual lists the full requirements and eligibility. **There currently is \$19 million available for the Northern Region which includes Plumas County and applications are being accepted until December 13, 2023.**

The second rebate program is called Communities in Charge and offers rebates for the purchase and installation of Level 2 chargers. This program allows installations at almost any site type, other than single family homes, so a park would be eligible. More information on this rebate program can be found <https://thecommunitiesincharge.org/>. **This project also currently has funding available in the Northern Region with \$8 million available.** The project's [Implementation Manual](#) covers the full requirements and eligibility. This project's funding window closes on December 22, 2023.

Both rebate programs rank applications by readiness tiers, meaning how much groundwork has already been completed. I recommend reviewing the readiness tier requirements in the implementation manuals to determine what are the minimum requirements to apply.

Let's get moving on this! And, please forgive me if you already have this information and are working on the EV chargers. Dame Shirley would be an perfect site for them!

Vote NO to selling DSP on OCT 17th !
