- Central Plumas: Sierra County adding AED and using the app pulsepoint. Replacing expired equipment (pads)
- Lake Almanor: No updates
- Eastern Plumas: A Letter of Intent has been submitted July 2023. Still working on application. Had 2 community events: Healthier Portola and the Health Fair.

Almanor Basin EMS Coverage:

- Chester Fire is in financial trouble- unknown if it will be resolved
- There is issue with EMS coverage, with Peninsula Fire District willing to assist short term, but there is also leadership change within Peninsula Fire
- According to Chief Balzarini they are taking it month to month and are hopeful.

Update of Rural EMS training grant:

- Received a one-year extension
- Graduation ceremony on Nov 17 at UNR with 10 graduating
- Part of grant: Critical Care Paramedic with is a self-paced program with a national board test after training has been completed.

PCSO- Communication Update:

- Since BOS approved pay increase for SO, one dispatcher re-hired with 2 more in hiring process
- No longer responsible for fire repeaters
- Quotes to replace EMS repeaters
- Federal DOJ grant for microwave system with Lassen County

- Graeagle Fire- Jim Stockdale:
 - Fire responsibility for Portola area with Graeagle Fire and Beckwourth Fire
 - Field save of a golfer at Whitehawk: CPR and AED utilized
- Seneca- Royce:
 - Ambulance issue in Chester area
 - State inspection
- REMSA/Careflight- Sam:
 - High Sierra music Festival was mellow compared to prior years
 - In Spring (March) an ambulance will be re-mounted
- EPHC- Dee Dee:
 - Staffing is good with flu vaccinations happening in Portola and Graeagle
- PDH- Zoe:
 - All good; nothing to report
- Air Methods- Louie:
 - Implement peer to peer support staffing
 - SEMSA: hire a few nurses but still issues with staffing and Air 2 is in and out of service

 - Emergency Alert platform changed from Code Red to Genasys: system wide test in November, still work in progress
