**Description of Project:** An Ordinance of the County of Plumas, State of California, amending Plumas County Code Title 9 Planning and Zoning, Chapter 2 Zoning, Article 2, Article 4, Article 5, Articles 13 through Article 26, Article 30, Article 31, Article 33, Article 34; and adding Plumas County Code Title 9 Planning and Zoning, Chapter 2 Zoning, Article 45; and amending Plumas County Code Title 9 Planning and Zoning, Chapter 9 State Responsibility Area Fire Safe Regulations, Article 4 of the Plumas County Code to establish an ADU Ordinance, including Junior Accessory Dwelling Units (JADUs) ministerial permit procedures, development standards, and regulations consistent with State ADU Law.
