A. Plumas County Board of Supervisors April 28, 2025, “Tributaries Forest Recovery Project” Draft Environmental Assessment/Initial Study (EA/IS) comment letter in support.

B. Governor Gavin Newsom signed the Room to Roam Act (Assembly Bill 1889), setting measures that will promote wildlife movement across the state directing cities and counties to minimize the disruption of wildlife movement and offers development guidelines such as incorporating wildlife-friendly fencing and lighting, which complements the Safe Roads and Wildlife Protection Act (Assembly Bill 2344), which requires the California Department of Transportation to prioritize wildlife crossing structures when improving or building roads, as well as the California Ecosystems Protection Act of 2023 (Assembly Bill 1322) and the Poison-Free Wildlife Act (Assembly Bill 2552), which make landscapes safer for wildlife by limiting toxic rodenticides. The state press release also mentions the Room to Roam Act also helps California meet its 30x30 goal to conserve 30% of the state’s lands and waters by 2030.
