Meeting of the Plumas County Transportation Commission (PCTC) is called to order by Chair Pat Morton with roll call at 1:30 PM in the Conference Room of the Plumas County Public Works Department.

- Discussion regarding the Carmichael School lower Speed Zone to 15-MPH which will require a more in depth speed study.
- Striping in Portola scheduled in Fall of 2025
- Sierra County to donate their funds from the Low Carbon Transit Operating Program to PCTC totaling \$8,511.

**TITLE:** Approval of Resolution No. 25-12, Accepting Sierra County Local Transportation Commission as a contributing sponsor for the FY 25/26 Low Carbon Transit Operations Program (LCTOP), for the purpose of supporting the Plumas Transit Services Free Fare Program.

---

**SUMMARY:** The LCTOP is a California State program providing funding to transit agencies to assist in programs that lower greenhouse gas emissions and improve mobility, with a focus on serving disadvantaged communities. The LCTOP is allocated annually by Caltrans to eligible transit agencies. For 2025 Plumas County Transportation Commission (PCTC) allocation request package consisted of \$48,699 for PUC § 99313 and \$7,581 for PUC § 99314 totaling \$56,280. The Sierra County Transportation Commission (SCTC) offered PCTC their remaining LCTOP funds in the amounts of \$8,196 for PUC § 99313 and \$315 for PUC § 99314 bringing the updated LCTOP allocation request package to a total of \$64,793.

In prior LCTOP allocations, Plumas County Transportation Commission (PCTC) has authorized the use of allocated LCTOP funds to fund the Plumas Transit Services Free Fare Program. The Plumas Transit Services Free Fare Program has led to increased ridership levels and reduced the financial burden on disadvantaged communities seeking transportation services. SCTC's additional funds as a contributing sponsor will allow for funding additional free fares and expanding advertisement for the program.

**WHEREAS**, the Plumas County Transportation Commission intends to utilize LCTOP funds to support and sustain the County's fare-free bus program; and

**NOW, THEREFORE, BE IT RESOLVED** by the Plumas County Transportation Commission that the fund recipient agrees to comply with all conditions and requirements set forth in the Certification and Assurances and the Authorized Agent documents and applicable statutes, regulations and guidelines for all LCTOP funds; and

**NOW THEREFORE, BE IT FURTHER RESOLVED** that the Executive Director is authorized to execute all required documents of the LCTOP program and any Amendments thereto with the California Department of Transportation.

**TITLE:** Update on Court Street Traffic Impact Study and planned stakeholder outreach

---

**SUMMARY:** The Court Street Traffic Impact Study proposes changes to Court Street at its intersection with Main Street in Quincy. A Transportation Impact Study (TIS), prepared by TJKM Transportation Consultants, was completed on April 9, 2025, to evaluate potential effects associated with the closure.

The study also analyzed two closure scenarios:

- Scenario A (total closure of Court Street at Main Street)
- Scenario B (partial closure, which retains right-turn movements from Court Street onto Main Street).

Under both closure scenarios, all study intersections and roadway segments were found to operate within Plumas County's Level of Service (LOS) standards. No significant delays or capacity issues were identified, and all 95th-percentile queue lengths were within acceptable limits. The LOS findings are consistent with the thresholds set forth in the 2035 Plumas County General Plan Circulation Element, which identifies LOS "D" as acceptable for areas with Community or Specific Plans, and LOS "C" elsewhere in the County.

The study also assessed pedestrian, bicycle, and transit impacts. The proposed closure is not expected to conflict with existing pedestrian or bicycle infrastructure or decrease user safety. Transit service provided by Plumas Transit Systems may require rerouting or relocation of the bus stop currently located on Court Street. Existing sidewalks, crosswalks, and pedestrian connections are expected to remain accessible.

Staff recommend moving forward with planning for the total closure of Court Street at Main Street. The closure is not anticipated to result in significant transportation impacts and will stay consistent with the County's transportation goals. Coordination with Plumas Transit will be necessary to address minor adjustments to bus stop locations or routing as part of implementation.

Planned stakeholder outreach will include a range of events such as public workshops, focus group meetings, community pop-up booths, and briefings to local advisory committees.


