Description of Nature, Purpose and Beneficiaries of Project:

Under the SWP Transfer, Plumas County will provide Westside, Lost Hills, Berrenda Mesa and Belridge WD, (WDWA) subcontractors to Kern County Water Agency, with 925 acre-feet of Plumas' SWP water supplies currently being stored in San Luis Reservoir. The point of delivery will be the California Aqueduct Reach 1. WDWA will use the water for any lawful SWP purpose within its service area.


Reasons why project is exempt:

The transfer of water will occur in place within California Aqueduct Reach 1, during 2025, using water that is surplus to Plumas' needs. All conveyance and use of water to and by WDWA will use existing water conveyance and storage facilities with negligible or no expansion of existing use. The project will not involve any construction or alteration of existing facilities. Transfer of Plumas SWP water will not alter existing WDWA SWP allocations.
