This is to advise that the Lahontan Regional Water Quality Control Board is proposing to amend the *Water Quality Control Plan for the Lahontan Region* in accordance with a regulatory program exempt under Section 21080.5 of the Public Resources Code from the requirement to prepare an environmental impact report under the California Environmental Quality Act (Public Resources Code Section 21000 et seq.) and with other applicable laws and regulations.

The Proposed Amendments and Substitute Environmental Document are available for review on the Lahontan Water Board's website at <http://www.waterboards.ca.gov/lahontan/> under the link for **Basin Planning/Basin Plan** and at the Lahontan Water Board's office in South Lake Tahoe. The Proposed Amendments include amending certain waste discharge prohibitions, adding mixing zone provisions, updating the Lake Tahoe Basin chapter, and updating non-regulatory portions of various sections. Because no significant or potentially significant adverse environmental impacts will result from the project, no analysis of reasonable alternatives to the project and required mitigation measures is presented. (Cal. Code Regs. tit. 23, §3777, subd. (e).)

The Lahontan Regional Water Quality Control Board will accept written comments on the Proposed Project and Environmental Analysis that are submitted by March 14, 2014 at 5:00 PM. Comments shall be submitted to Chuck Curtis, Lahontan Water Board, 2501 Lake Tahoe Blvd., South Lake Tahoe, CA 96150. A public hearing for the receipt of oral comments is scheduled for the Water Board's regular meeting of April 9-10, 2014 at the Water Board's annex office at 971 Silver Dollar Avenue, South Lake Tahoe; the
