STATE BUDGET BRIEFING

Report and update by Jack Ingstad, CAO on the Governor's May Revise. The Governor released his May Revise state budget on May 14, 2008 and stated that the budget shortfall for FY 2008-2009 has grown to \$17.2 billion. That figure includes a reserve of \$2 billion. Mr. Ingstad is concerned with the additional \$627m included in reductions to Health and Human Services programs, primarily in Medi-Cal, IHSS, CalWorks and SSI/SSP. The proposed reductions will have a significant impact on the Department of Social Services programs as outlined in a report from Elliott Smart, Director.

In regard to the FY 2008-2009 Plumas County budget, the County remains solvent. All department budgets have been submitted and requests remain conservative or status-quo. Mr. Ingstad informs the Board that because they have remained conservative over the past two fiscal years, the County is stable financially.

Mr. Ingstad will continue to track the State budget and update the Board.
