GASB ACTUARIAL VALUATION

Presentation by Marilyn Jones representing The Epler Company of the actuarial valuation conducted on behalf of the County for its retiree health program as of July 02, 1007. 6. PLANNING DEPARTMENT

CONTINUED PUBLIC HEARING – APPEAL OF ZONING ADMINISTRATOR/TENTATIVE PARCEL MAP (MCMORROW)

Appeal of Zoning Administrator's decision to approve tentative parcel map dividing 51.13 acres into four parcels of 10.58, 10.19, 10.11, and 10.17 acres with a remainder of 10.10 acres for single-family residential use. This project is located at 2945 River Dance Road, Quincy. APN 005-520-001 (McMorrow, John & Elizabeth). This matter is continued from May 13, 2008. The public hearing is limited to staff's response to comments submitted by High Sierra Rural Alliance.

Staff recommendation is to continue the public hearing indefinitely. New outside counsel has been retained by the County and is reviewing this project. This review has not yet been completed.

The Chair takes comments from the applicant, John McMorrow. Mr. McMorrow reminds the Board that the Zoning Administrator has reached a decision and finds that the proposed project is consistent with the General Plan. Mr. McMorrow requests that the Board close the public hearing.

Counsel objects to the request of Mr. McMorrow and recommends the Board uphold staff's recommendation to continue the matter.

Following discussion by the Board, motion by Supervisor Meacher, second by Supervisor Powers and carried to continue the public hearing on the tentative parcel map not to a date and time specific to allow time for counsel to review the project. The Planning Department will re-notice the public hearing.
