REGULAR MEETING OF THE BOARD OF SUPERVISORS COUNTY OF PLUMAS, STATE OF CALIFORNIA HELD IN QUINCY ON OCTOBER 7, 2008

STANDING ORDERS

ROLL CALL

The meeting is called to order at 10:00 a.m. with Supervisors William Powers, Sharon Thrall, Robert Meacher Ole Olsen and Chair Rose Comstock present.

INVOCATION AND FLAG SALUTE

Pastor Tarleton from the First Baptist Church of Quincy offers the invocation and Supervisor Thrall leads the flag salute.

PUBLIC COMMENT OPPORTUNITY

Jim Murphy, Portola City Manager, presented a letter from the Portola City Council regarding the California Department of Justice Interagency Agreement for CLETS access and requested this matter be put on a future agenda for review and possible action.

Dean Tedford, Chair, Plumas County Alcohol & Drug Advisory Committee, presented a letter of concern regarding future A&D services and requested this matter be put on a future agenda for review and discussion.

Larry Douglas announced he had attended a agriculture workshop and would like the Board to consider alternatives to pesticide use.

John Sheehan, Director, Plumas Corporation made the following announcements:

- 1) Regional meeting of the Upstate California Economic Development Council reception to be held 10/16/08 at Chalet View; requested Board attendance
- 2) an award day at Antelope Cabin: major projects include North Valley Road-fire safety, disabled elderly home projects; 110 acre LaPorte chip project; Little Grass Valley project

ACTION AGENDA

1. COUNTY ADMINISTRATIVE OFFICER

A. Legislative Update

1. Jack Ingstad, CAO, announced the passage of Secure Rural Schools (SRS) and PILT funding by Congress. SRS funding will continue to 2011; PILT funding will continue to 2012. The CAO stated he is waiting for clarification on when payments will occur. Discussion followed. Supervisor Olsen stated his appreciation of Supervisor Comstock's efforts to secure this funding.

B. Departmental Matters:

1. COUNTY ADMINISTRATIVE OFFICE

Approve and authorize Administrative and Budgetary Furlough Controls for FY 08-09.

Mr. Ingstad reiterated the reasons for the budget adoption of four furlough days. He stated the savings would be approximately \$57,000 in the Road Department and approximately \$140,000 in the General Fund. He noted that the Road Department would not be fully funded even with the current passage of the SRS/PILT funding. He also noted concerns about State funding and the County's interest earnings. He stated his concern about County morale over the furlough issue. Discussion followed. Gayla Trumbo, Human Resources Director, stated the administration of the furlough days would be an added cost for her department and the Auditor's department. She stated she had been contacted by department heads who had concerns over benefits. She stated PERS would be affected, and she will clarify and address this issue.

Supervisor Thrall would like to reexamine furloughs due to the hardships on employees during this economic down turn.

Supervisor Comstock stated she supported the budget as adopted.

Supervisor Meacher requested a cost analysis of the administration of the furloughs.

Lori Simpson, Supervisor-Elect, stated she had been contacted by employees who were opposed to the word "reserves" as the reason for furloughs.

CAO Jack Ingstad requested that Interim County Counsel (Labor) research this issue and the matter be continued to the next week. Consensus of the Board to continue this matter to October 14, 2008.

2. COUNTY CLERK/ELECTIONS

Following discussion and recommendation by CAO, motion by supervisor Meacher, second by Supervisor Thrall to approve and authorize an exemption to the FY 2008-2009 Administrative and Budgetary Controls to be exercised by the CAO regarding limitation on extra and/or temporary help in the Elections Division of the Clerk-Recorder's Office. B. ORDINANCE: LITTLE GRASS VALLEY – Roll Call Vote

Motion by Supervisor Powers, second by Supervisor Olsen, to approve the amendment to the ordinance as presented by County Counsel, first read on May 20, 2008, Amending Section 10-2.02 of Title 10 of the Plumas County Code, and modify as an amendment “the granting document identified as ‘Conveyance and Agreement’ dated October 31, 1969, between Oroville-Wyandotte Irrigation District and Frank J. and Mary M. Anderson, and recorded March 09, 1970, in Volume 193, Page 104 of Official records, Plumas County Records,” and continue to October 14, 2008 as modified for final adoption as amended.

She presented the Plumas County Family Violence Prevention Coalition Proclamation which proclaims October 2008 as Domestic Violence Awareness Month in Plumas County.
