PUBLIC HEARING – Appeal of Zoning Administrator's decision to approve a Tentative Parcel Map for John and Elizabeth McMorrow.

Stevee Duber, appellant representing High Sierra Rural Alliance submits information to the Clerk to be included in the public record. Ms. Duber requests the public hearing be continued for an additional thirty days to allow for time to review any new information presented by the Planning Department.

Pete Hentschel, Attorney representing applicant John and Elizabeth McMorrow are opposed to the request for a continuance of the public hearing. Mr. Hentschel informs the Board the applicant concurs with the recommendation being made by the Planning Department and requests the Board proceed with the public hearing.

Following discussion, motion by Supervisor Thrall and second by Supervisor Powers to continue the Public Hearing to November 04, 2008 at 1:30 p.m. to allow for the appellant, High Sierra Rural Alliance, to review and address any new information as presented by Planning Department staff; allow for appellant to present any new information in regard to the tentative map; and allow for rebuttal by the applicant, John and Elizabeth McMorrow.
