Project Title: Lights Creek Bridge Rehabilitation Project

Project Applicant: Plumas County Department of Public Works

Project Location: The project site is located on County Road 112 (North Valley Road), over Lights Creek, adjacent to the intersection with Diamond Mountain Road and north of Taylorsville. The project site is located in the northeast $\frac{1}{4}$ of Section 22, Township 26 North, Range 10 East, Mount Diablo Base and Meridian (MDBM).

Description of Nature, Purpose or Beneficiaries of Project: The proposed project is the rehabilitation of the Lights Creek Bridge. The steel truss will be retained and its service life extended by blasting, cleaning, and painting all steel elements. The concrete bridge deck will be cleaned and treated with methacrylate or polyester concrete overlay. The roller bearings and abutment seats will be cleaned and the roller bearings at Abutment 3 reset. Resetting the bearings will require temporary bridge closure while the bridge is jacked. Jacking activities require equipment in the channel, underneath the bridge. Minor preventative maintenance repairs are required to steel elements of the truss and both abutments require appropriate scour countermeasures. Proposed scour countermeasures are likely to a temporary road detour utilizing a temporary culvert placed in the creek channel under the bridge will be considered.
