

RESOLUTION NO. 10-7632

A RESOLUTION APPROVING THE SUMMARY VACATION OF AN EASEMENT FOR AN EASEMENT ROADWAY AND UTILITY PURPOSES LOCATED AT THE INTERSECTION OF GRAEAGLE-JOHNSVILLE ROAD AND MOHAWK HIGHWAY ROAD.

Whereas, the Board has elected to proceed under the Provisions of the Public Streets, Highways, and Service Easements Vacation Law (Division 9, Part 3 of the California Streets and Highways Code), and specifically Chapter 4 (commencing with Section 8330) thereof and summarily vacate a portion of an easement for Roadway and Utility purposes located at the intersection of Graeagle-Johnsville Road and Mohawk Highway Road.

Now, Therefore, Be It Hereby Resolved by the Board of Supervisors of the County of Plumas, State of California, under that Section 8330 *et seq.* of the Streets and Highway Code of the State of California that the easement located at the intersection of Graeagle-Johnsville Road and Mohawk Highway Road is summarily vacated.

Be it further Resolved that the Clerk of the Board of Supervisors shall cause a certified copy of this resolution to be recorded as provided under Section 8330 *et seq.* of the Streets and Highways Code of the State of California, and

Be it further Resolved that from and after the date this Resolution is recorded, the above described easement no longer constitutes a roadway or utility easement.


