

**RESOLUTION NO. 21 - 8640**

**A RESOLUTION AMENDING PORTIONS OF THE MASTER FEE SCHEDULE FOR WEIGHTS AND MEASURES PURSUANT TO THE AMENDMENT OF CCR, TITLE 4, DIVISION 9, CHAPTER 3, SECTIONS 4075, EFFECTIVE APRIL 21, 2021**

**WHEREAS**, the Board of Supervisors of the County of Plumas, State of California, has previously adopted a Master Fee Schedule establishing service fees for county departments; and the most recent schedule was adopted on October 16, 2012, by Resolution No. 12-7792; and

**WHEREAS**, the California Department of Measurement Standards has required that local offices implement a fee increase to various weighing and Measuring devices effective April 21, 2021 and to be implemented on the next billing cycle for Plumas County which commences January 1, 2022.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors, County of Plumas, State of California, as follows:

1. The Master Fee Schedule adopted by Resolution No. 12-7792 is hereby amended in part as referenced by the following, with no other part of the Master Fee Schedule amended;
