She helped a client file a grievance regarding denial of services. Assisted former client with ROI and Records Release forms. Assisted EA client obtaining forms from library. 4 phone calls from EA client. 1 phone call from FSP client re: housing.
- c. Secretary/Treasurer Report (Kendrah) – Attended QIC meeting. Also thanked Tony for his service to BH and Plumas Co. clients.

3. Behavioral Health Department

- a. Director's Report (Dr. Tony Hobson) – Tony thanked everyone for their kind words. In the transition: Sharon Sousa will be the interim director – she is surrounded by good

individuals. They are filling some vacancies, e.g. site coordinator (interviews have been set-up). Recruiting for Drug & Alcohol Admin. – will help with State Quality Assurance. Jessica is primarily doing QA for Mental Health. BH has a strong administrative team.

- b. Quality Assurance Improvement (Jessica M.) – EQRO was held 4/20 (doing well), Triennial scheduled for 5/17-5/18, Cal-AIM implementation plan accepted (no wrong door), Consumer Perception Survey scheduled for 5/16-5/20, many Informational Notices (BHIN – 12, 13, 15, 16, 17, 18, 20, 21).

360 open charts (down 6%); 104 youth, 284 services; 41 new intakes; 11 crisis; 12 psych placements

3 quality of care grievances, 1 confidentiality concern (unsubstantiated), 1 appeal, 1 medication concern, 2 behavior concerns

High level of wraparound care. #1 in state for hospitalization recovery – able to transition to lower level of care quickly. 2 days for wraparound to take affect.

- c. Behavioral Health Commission Information and Improvement – Kendrah mentioned to BOS Kevin that Commission members sit-in on BH Director interviews.
