- a. Director's Report (Sharon Sousa) – Denise requested that Sharon speak about the 988 Suicide & Crisis Hotline #. This went live on July 16th – can call, text or chat. There is a special option for veterans, Spanish-speaking, etc. Funded by SAMHSA. Yolo Co. call center covers Plumas Co.

PCBH applied for a 4-year grant for services in the school district and this was awarded. This started July 1, 2022 and covers public and charter schools, students, teachers, and staff. A therapist will be in the schools. Serena Retallack will be the coordinator. Telehealth will also provide services.

PCBH has at several staff vacancies and thus, is in the process of setting up a contract with IRIS for 2 full-time Telehealth therapists.

Sharon reported: They are working toward implementing Cal-AIMS – doing training, changing electronic health records to Cal-AIMS forms.
