

**INDEPENDENT ACCOUNTANT'S REPORT ON AGREED-UPON PROCEDURES
APPLIED TO APPROPRIATION LIMIT CALCULATION**

To the Board of Supervisors
County of Plumas
Quincy, California

We have performed the procedures enumerated below to the accompanying Appropriations Limit worksheet of the County of Plumas, for the year ended June 30, 2016. These procedures, which were agreed to by the County of Plumas, were performed solely to assist the County in meeting the requirements of Section 1.5 of Article XIII B of the California Constitution. The County of Plumas management is responsible for the Appropriations Limit worksheet. This agreed-upon procedures engagement was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. The sufficiency of these procedures is solely the responsibility of the County of Plumas. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

The procedures performed and our findings were as follows:

1. We evaluated the accuracy of the computation and adequacy of the documentation. We obtained the completed worksheets, and compared the limit and annual adjustment factors in those worksheets to the limit and annual adjustment factors that were adopted by resolution of the County Board of Supervisors. We also evaluated the County's compliance with Government Code Section 37200.

Finding: No exceptions were noted as a result of our procedures.

2. We determined compliance with the Appropriations Limit. We compared the proceeds of tax subject to the limit to the calculated limit.

Finding: No exceptions were noted as a result of our procedures.

3. We determined that the Appropriations Limit resulting from the completion of the various worksheets was adopted by the Board of Supervisors. We noted that the Limit was approved by the Board of Supervisors on June 9, 2015.

Finding: We noted that the prior year appropriations limit was included in the current year State Controller's report.


4. We compared the prior year appropriations limit presented in the current year appropriations limit calculation to the prior year appropriations limit adopted by the Board of Supervisors.

Finding: No exceptions were noted as a result of our procedures.

Notes to Appropriations Limit Worksheet
For the Year Ended June 30, 2016

NOTE 1: PER CAPITA PERSONAL INCOME FACTOR

The per capita personal income factor was obtained by using the percentage factor from the State Department of Finance letter dated May 1, 2015. The CPI change was (3.28) percent. This percentage was converted to a ratio and for calculation purposes was 1.0382.

NOTE 2: POPULATION CHANGES

There are three methods of calculating the change in population that a County may choose in determining the Gann Limit. 1) The change in population within its jurisdiction; 2) The change in population within its jurisdiction, combined with the changes in population within all counties having borders that are contiguous to that county; 3) The change in population within the incorporated portion of the county. The county may use either of these methods in any year.

The County has elected to use the change in population within its jurisdiction, combined with changes in population within all counties having borders that are contiguous to that County (method 2). The population change percentages for the County as well as the population change percentages for all counties having borders that are contiguous to Plumas County were taken from the May 1, 2015 letter from the State Department of Finance. This combined percentage was converted to a ratio and for calculation purposes was .9938.

NOTE 3: APPROPRIATION LIMIT

The County has calculated the proceeds of tax for the year ended June 30, 2016 as \$15,199,070. The appropriation limit for the year ended June 30, 2016 is \$31,091,818, therefore, the proceeds of tax is \$15,892,748 less than the appropriations limit. The proceeds of tax is 48.9 percent of the limit.
