#6 - Hand sink in kitchen: supply single use soap and paper towels immediately. No soap or paper towels available at time of inspection.

#34 - Repair dishwashing unit to supply 50ppm min. Chlorine for sanitizing cycle. At 0ppm at time of inspection.

- Sanitize by hand at 100ppm chlorine until dishwasher fixed.

- Monitor chlorine level with test strips

#45 - Repair counter backsplash behind hand sink

- Hole in wall behind 3-compartment sink as noted on 9/20/18 inspection has been repaired
