(c) Easements for guy wires and anchorages extending 20 feet from the center—lines of easements referred to in (a) above, and five feet in width, at the location shown hereon by symbols.

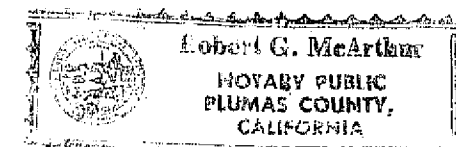
