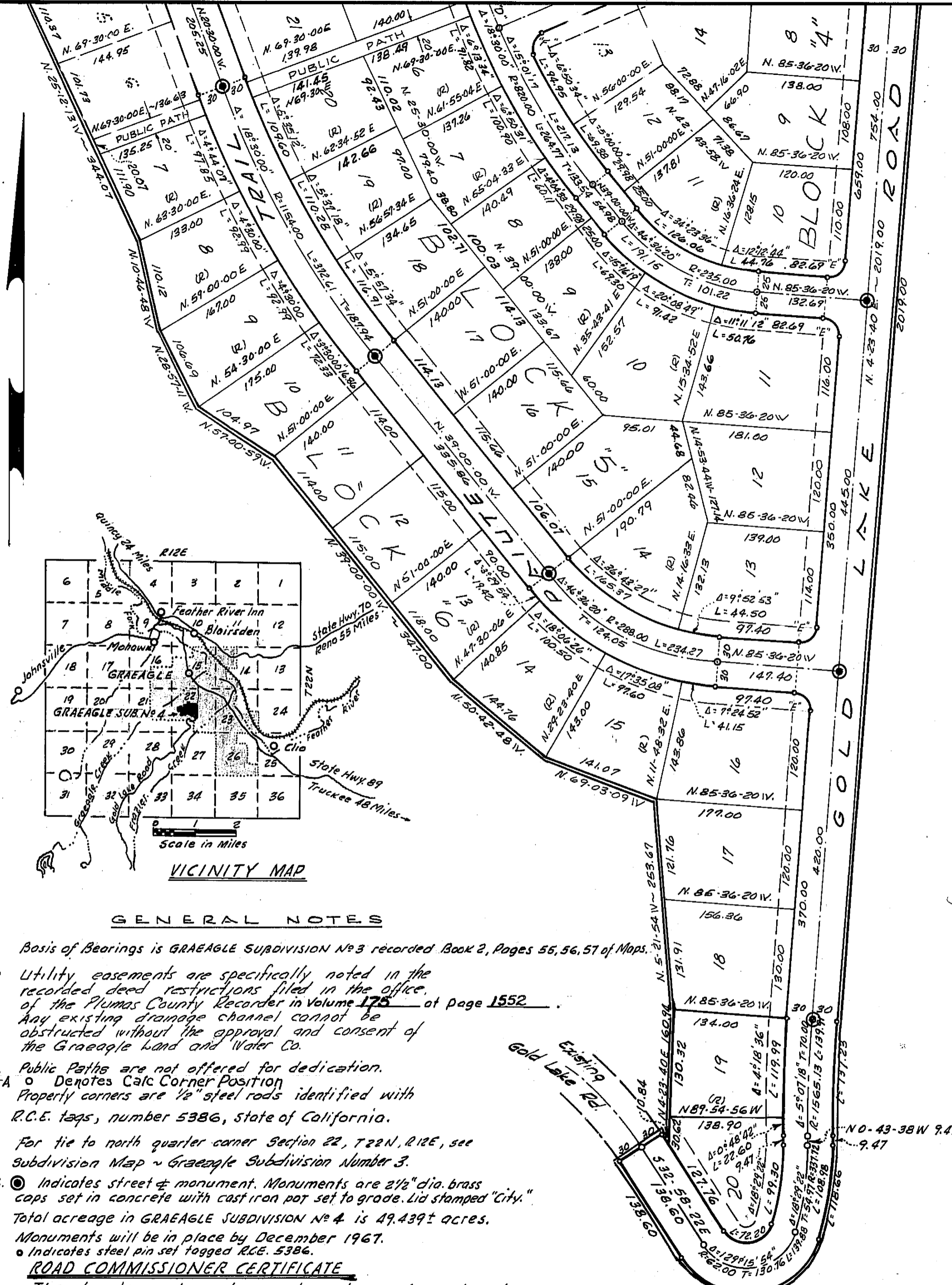
CERTIFICATE OF TAX COLLECTOR

2. Utility easements are specifically noted in the recorded deed restrictions filed in the office of the Plumas County Recorder in Volume 175 at page 1552. Any existing drainage channel cannot be obstructed without the approval and consent of the Graeagle Land and Water Co.
3. Public Paths are not offered for dedication.

4. Property corners are $\frac{1}{2}$ " steel rods identified with R.C.E. tags, number 5386, State of California.
