OWNER'S CERTIFICATE

AND CAL-SIERRA TITLE COMPANY, A CALIFORNIA CORPORATION,
DIXIE VALLEY LTD., A LIMITED PARTNERSHIP, AS OWNERS OF THE LAND INCLUDED
WITHIN "DIXIE VALLEY PROPERTIES," AS SHOWN ON THE ANNEXED MAP, AND FIRST
AMERICAN TITLE COMPANY, A CORPORATION, AS TRUSTEE UNDER DEED OF TRUST
DATED OCTOBER 20, 1970 AND RECORDED NOVEMBER 5, 1970 IN VOLUME 199 OF
PLUMAS COUNTY OFFICIAL RECORDS, AT PAGE 8, DO HEREBY CERTIFY THAT WE
ARE THE ONLY PERSONS WHOSE CONSENT IS NECESSARY TO PASS CLEAR TITLE
TO SAID LAND, AND WE CONSENT TO THE PREPARATION AND RECORDATION OF
SAID MAP AS SHOWN WITHIN THE COLORED BORDER LINES. CAMEO COURT,
SIERRA COURT, AND ASPEN COURT AS SHOWN WITHIN THE COLORED BORDER LINES
ON SAID MAP ARE PRIVATE ROADS, BUT SUBJECT TO EASEMENTS OVER AND ALONG
AND WITHIN SAID ROADS FOR PUBLIC UTILITY FACILITIES AND DRAINAGE. WE,
ALSO OFFER FOR DEDICATION AND DO HEREBY DEDICATE FOR SPECIFIC PURPOSES,
THE FOLLOWING:

(A) RIGHTS OF WAY AND EASEMENTS FOR WATER, GAS, SEWER, AND
DRAINAGE PIPES AND FOR OVERHEAD AND UNDERGROUND WIRES FOR ELECTRIC
AND TELEPHONE SERVICES, TOGETHER WITH ANY AND ALL APPURTENANCES
APPERTAINING THERETO, ON, OVER, AND UNDER THOSE STRIPS OF LAND
DESIGNATED "PUBLIC UTILITY EASEMENT"

(B) EASEMENT FOR LIGHT AND AIR OVER THOSE STRIPS OF LAND LYING
BETWEEN THE FRONT AND/OR SIDE LINES OF LOTS AND THE LINES SHOWN
HEREON AND DESIGNATED "SETBACK LINE," SAID STRIPS TO BE KEPT OPEN
AND FREE OF BUILDINGS.

(C) EASEMENTS FOR GUY WIRES AND ANCHORAGES EXTENDING 20 FEET
FROM THE CENTER LINES OF EASEMENTS REFERRED TO IN (A) ABOVE AND
4 FEET IN WIDTH AT LOCATIONS DETERMINED BY THE UTILITY COMPANY.

(D) NO CONSTRUCTION TO BE ALLOWED WITHIN THE LIMITS OF THE
DRAINAGE EASEMENTS, SCENIC EASEMENTS, OR MEADOW AREAS AS SHOWN HEREON,
EXCEPT DRIVEWAYS AT DESIGNATED LOCATIONS ON LOTS 50, 51, 52, 53, 54, 55, 56, 91, 92.

(E) BUILDINGS ON LOTS 12, 13, 32, 33, 34, 38, 39, 47, 48, 49, 72, 85,
91, 94 AND 96 SHALL BE LIMITED TO THOSE PORTIONS OF THE LOT INDICATED
AS BUILDING SITES.

(F) LOTS SHOWN HEREON SHALL FURTHER BE SUBJECT TO THE COVENANTS,
CONDITIONS AND RESTRICTIONS TO BE RECORDED SIMULTANEOUSLY WITH THIS
PLAT.

(G) THE USE OF LEACH FIELDS FOR SEPTIC DISPOSAL WILL NOT BE
ALLOWED ON THOSE LOTS SHOWN HEREON WITH CIRCLED LOT NUMBERS.

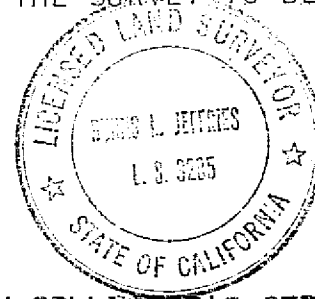
(H) THE UNITED STATES FOREST SERVICE ROAD 25 NO 6 SHOWN HEREON

(I) THE FIFTY (50.00) FOOT ROADWAY EASEMENT DESIGNATED "U.S.F.S.
ROAD 24 NO 8 Y.1" HEREON GRANTED TO THE U.S. FOREST SERVICE BY DEED
RECORDED IN BOOK 52, PAGE 192, PLUMAS COUNTY RECORDS.

(J) THE SIXTY-SIX (66.00) FOOT ROADWAY EASEMENT DESIGNATED "U.S.F.S.
ROAD 24N78X" HEREON GRANTED TO THE U.S. FOREST SERVICE BY DEED
RECORDED IN BOOK 52, PAGE 192, PLUMAS COUNTY RECORDS.

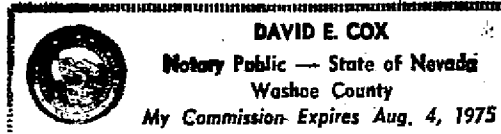
