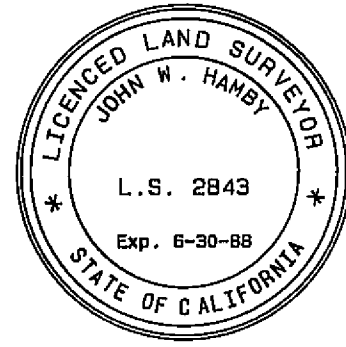


SURVEYOR'S CERTIFICATE

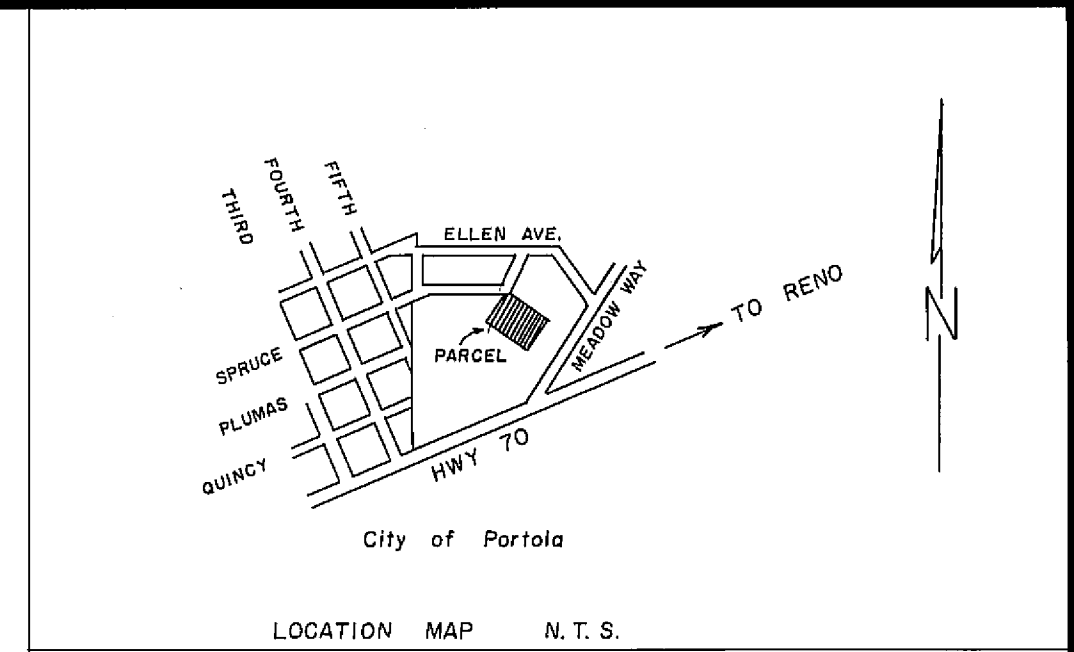

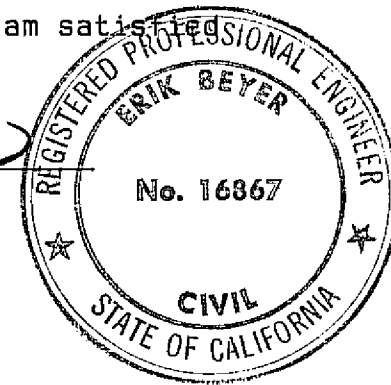


CITY ENGINEER'S CERTIFICATE

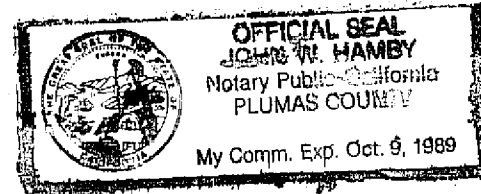
