1. THE BASIS OF BEARINGS FOR THIS MAP IS THE SOUTH LINE OF N-E 1/4 OF SECTION 16, GIVEN AS N89°56'39"W IN BOOK 5 OF RECORD OF SURVEYS AT PAGE 47, PLUMAS COUNTY RECORDS.
2. A 40 FOOT WIDE PRIVATE EASEMENT FOR INGRESS, EGRESS, PUBLIC UTILITY, DRAINAGE AND INCIDENTAL PURPOSES FOR THE BENEFIT OF PARCEL 4 AS SHOWN IN BOOK 7 OF PARCEL MAPS AT PAGE 74, PLUMAS COUNTY RECORDS, WILL BE GRANTED UPON RECORDATION OF THIS MAP.
3. THE NORTHWEST CORNER OF LOT 16 IS THE SAME CORNER AS THE SOUTHWEST CORNER OF PARCEL 2, AS SHOWN IN BOOK 7 OF PARCEL MAPS AT PAGE 74. THIS POSITION FALLS WITHIN THE SMITH CREEK CHANNEL AND THE MONUMENT PER SAID PARCEL MAP WAS NOT FOUND. A WITNESS CORNER WAS SET, OUT OF THE CREEK, ALONG THE COMPUTED COMMON PROPERTY LINE.
4. PRIVATE ROAD STATEMENT: MEADOWVIEW LANE AS SHOWN HEREON IS A PRIVATE EASEMENT NOT SUBJECT TO IMPROVEMENT OR MAINTENANCE BY PLUMAS COUNTY. SUCH EASEMENT WILL NOT BECOME EFFECTIVE UNLESS AND UNTIL A RESERVATION AND GRANT IS INCLUDED IN THE RESPECTIVE DEEDS.

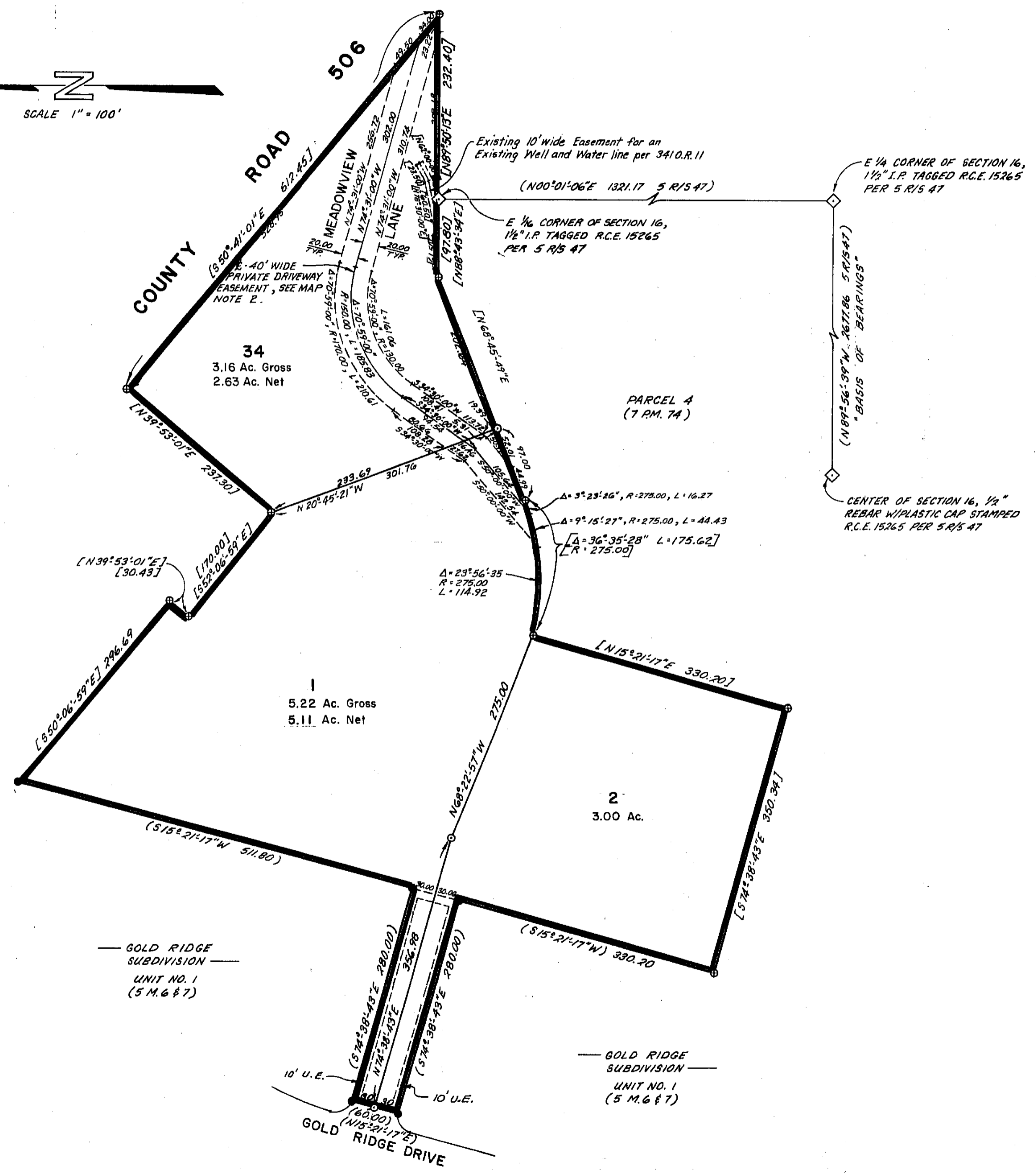
