- UNDERGROUND DRAINAGE EASEMENTS AS SHOWN ON THE MAP FOR CONSTRUCTION, RECONSTRUCTION, MAINTENANCE AND OPERATION OF UNDERGROUND STORM DRAINS AND APPURTENANCES.




