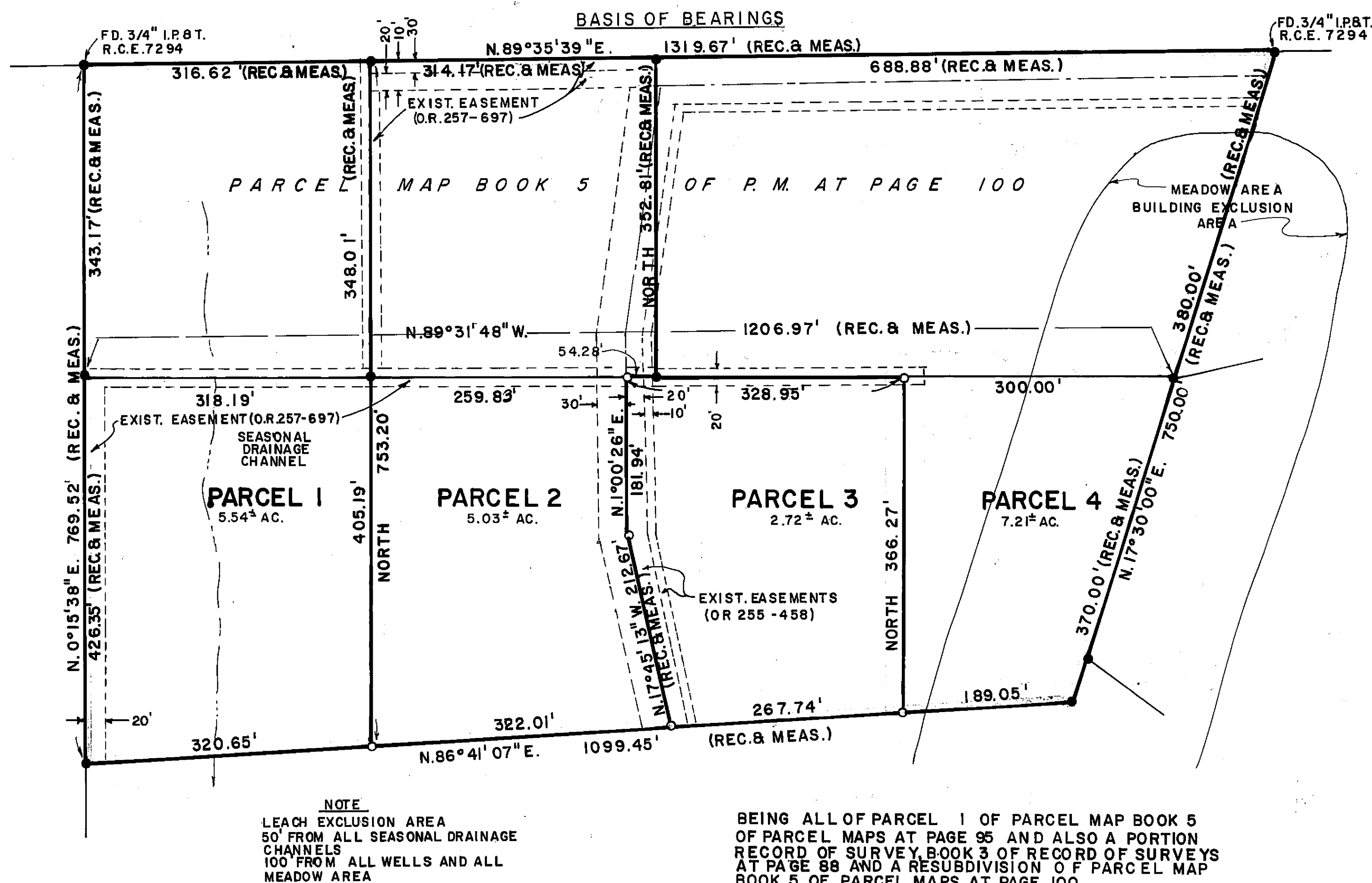


NOTE

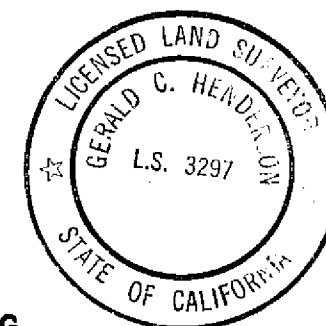
