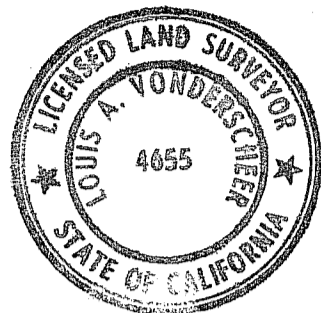


SURVEYOR'S CERTIFICATE.

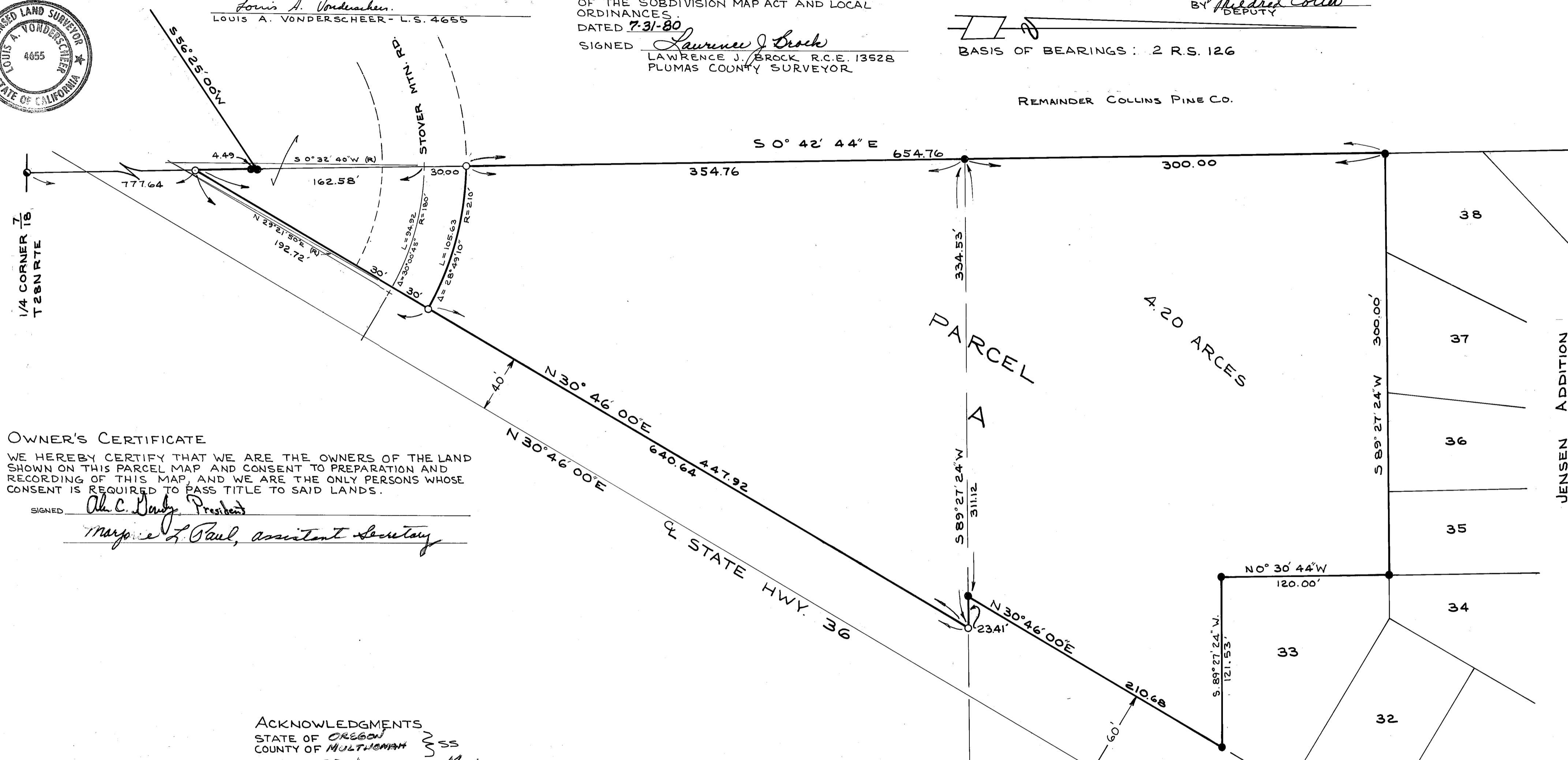
