

NOTES:



The certificate was signed by Richard Litov and stated that they consent to the preparation and recording of this map, and that they are the only persons whose consent is required to pass title to said land.

Leach exclusion areas are all areas within 50' of property lines, within easements, within 50' of watercourses, within 100' of wells, and for all slopes of 30% or greater.

The development and future use of wells upon any of the parcels of this map shall be subject to the requirements of the Sierra Valley Groundwater Management District.

This map is a division of Parcel 4 of 8 P.M. 34. Litov Court shown hereon is a private easement not subject to improvements or maintenance by Plumas County. Such easements will not become effective unless and until reservations and grants are included in the respective deeds.
