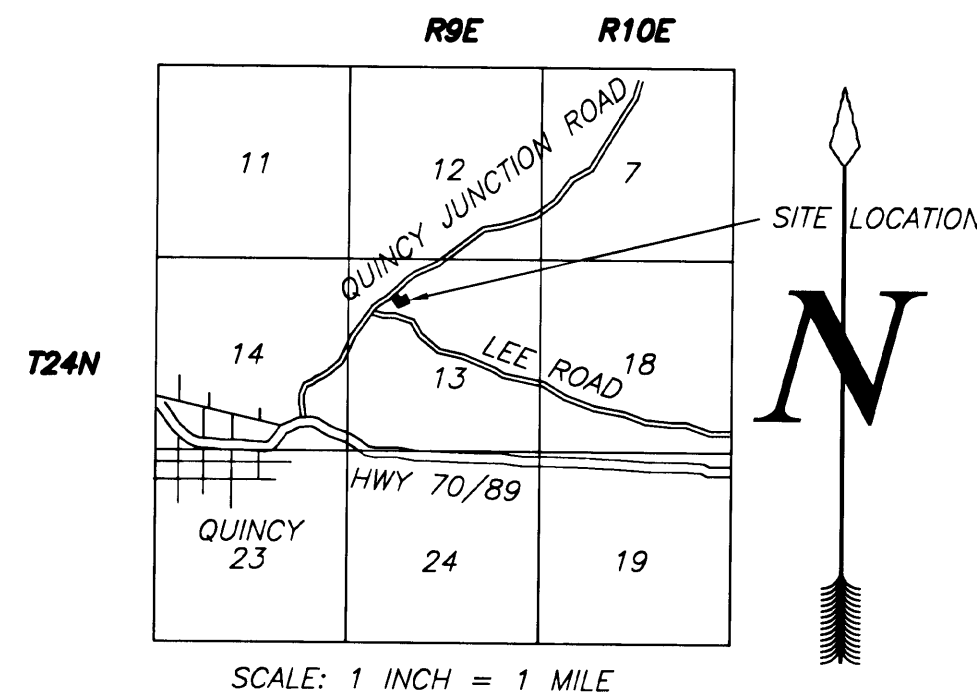


**COUNTY TAX COLLECTOR'S STATEMENT**

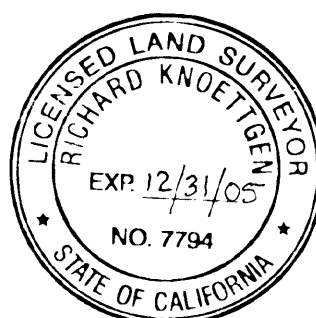
