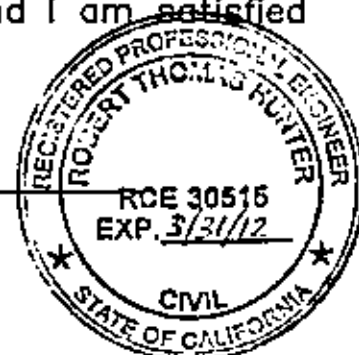
COUNTY SURVEYOR'S STATEMENT

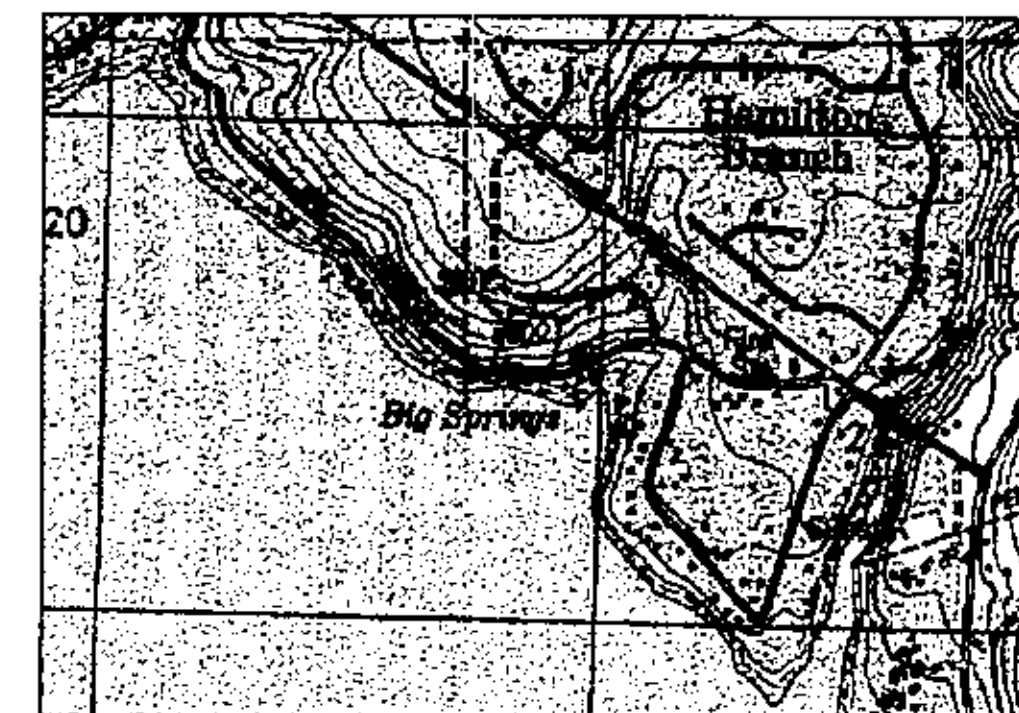

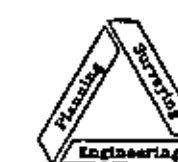


PARCEL MAP
