



THE THEORETICAL LOCATION OF THE NORTHEAST CORNER OF THIS SURVEY WAS COMPUTED FROM RECORD AND DEED WITH RESPECT TO THE FOUND SOUTHEAST CORNER OF PARCEL 2 AS SHOWN ON THAT CERTAIN RECORD OF SURVEY MAP OF THE LANDS OF R. E. TRALL, FILED IN BOOK 1 AT PAGE 120. THE EAST BOUNDARY WAS THEN ESTABLISHED ALONG THE RECORD BEARING OF 505°08'00" W. THE SOUTHWEST CORNER WAS SET FROM HIGHWAY RECORD AND FOUND HIGHWAY MONUMENTS. THE SOUTH BOUNDARY WAS THEN ESTABLISHED ALONG THE IMPLIED RECORD BEARING OF 509°52'00" E. THE FORCED CLOSURE THEN ESTABLISHED DISTANCES FOR BOTH EAST AND SOUTH BOUNDARIES
