

Resolution

The resolution of this survey is based on a property corner search and field survey of all found corners and an exhaustive review of numerous deeds, record maps, and unrecorded survey work performed by private surveyors and the County of Plumas. The County of Plumas performed a survey within portions of Lots 4, 5, 6 of Block 7 and Lot 12 of Block 6 in October 1977, for purposes of acquiring road right-of-way. Their survey tied in numerous property corners along South Main Street as well as verifying the South line of Section 3 between the quarter corner and the Southeast corner. The survey by the County appears to be the first survey of the South section line utilizing a electronic distance meter, and the only survey since 1962. Consequently the coordinates calculated from the County survey for points Δ through Δ were accepted and used in the resolution and adjustment of this survey after a field traverse, to verify their location in relation to this survey, was closed and adjusted. Bearings shown on Maps of Record used in this Resolution were rotated to coincide with the Basis of Bearing of this survey.

For clarity, a table is provided showing the record bearing and distance and source whenever the measured data is different, which is prevalent throughout the Bidwell Addition.

Point Δ is established by projection of the East line of Parcel "D" to the South line of the WPRR R/W as shown on references R_1 and R_{10} . Point Δ is the Southeast corner of Lot 5 on the South line of Section 3, which lies approximately 2.5 feet North of a fence post of long standing. Point Δ is the Southwest corner of Lot 7 of the Bidwell Addition, which lies approximately 0.5 South of a bent 3/4-inch iron pipe. The East line of Lot 5, South of the WPRR R/W was accepted as being along a fence of long standing, which accounts for the angle point at the South R/W of the WPRR.

The Record Map of the Bidwell Addition, R_2 , does not close by 0.47' North and South; Therefore, all the lots within the Bidwell Addition were adjusted and closed proportionally.

Points Δ through Δ were tied to the field survey and accepted as being in their proper position which accounts for the non-tangent sections at the end of several horizontal curves.

The Northwest corner of Lot 4, Point Δ , is established by proration of the record distance as shown on R_1 to the measured distance between Points Δ and Δ per R_5 and County coordinates for these points.

Point Δ (corner between Lots 1, 3, 4 and 6 of Block 7) was accepted from R_5 as noted on the resolution thereof. Parcel "E" is a remnant of Lot 6, Block 7 and there are no deeds or maps of record describing this parcel. Record maps R_8 , R_3 , R_7 and R/W data for Setzer Road and South Main Street obtained from the County were used in establishing the corner locations for Parcel "E" as follows: The Westerly corner of Parcel "E" was established by calculating its position from the 1-1/4" iron pipe in a double fir stump per R_8 and rotating it to fall on the South line of Setzer Road. The two most Northerly legs of Parcel "E" are record, per R_8 . The Northeasterly leg of Parcel "E" is parallel and 100 feet distant from the North line of Main Street established by found monuments per R_7 .
