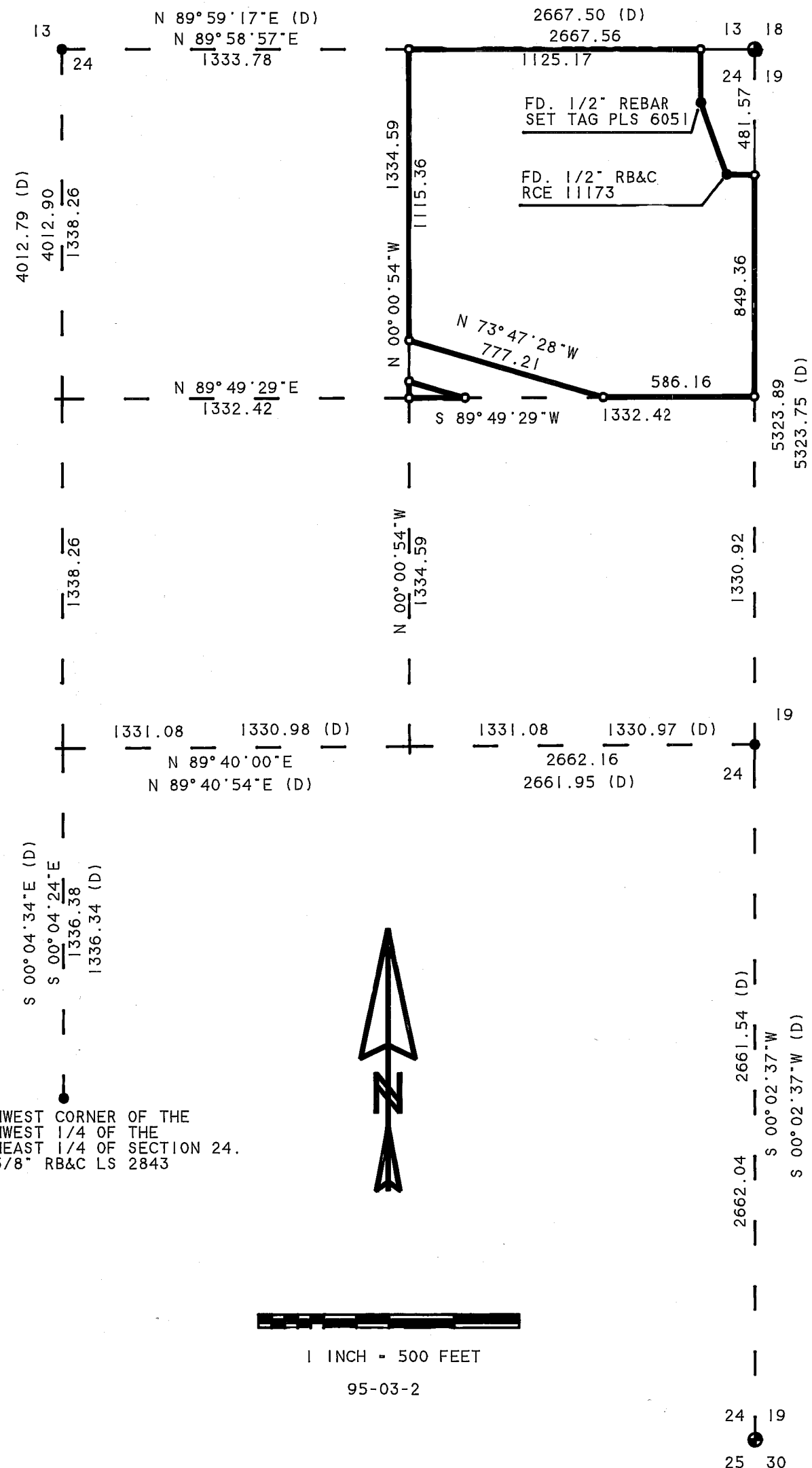


BASIS OF BEARINGS

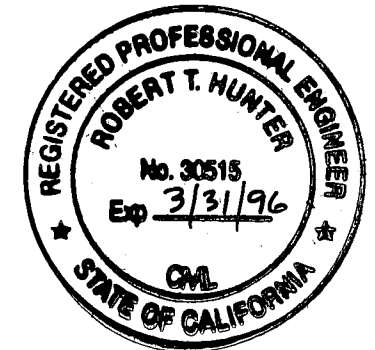
