THE BEARING OF N 84°38'46" E FOR THE SOUTH LINE OF PARCEL 1 FROM THE 3/4 INCH IRON PIPE & TAG R.C.E. 7294 AT THE PROPERTY CORNER COMMON TO PARCELS 1, 2, & 3 TO THE SOUTHEAST CORNER OF PARCEL 1, SHOWN IN BOOK 3 OF RECORDS OF SURVEYS AT PAGE 92 IS THE BASIS OF BEARINGS SHOWN ON THIS MAP.

NOTES

1. THE 3/4 INCH IRON PIPE AND TAG R.E. 292 IS NOT SHOWN IN BOOK 3 OF RECORDS OF SURVEYS AT PAGE 92, BECAUSE SAID MONUMENT IS SUBSTANTIALLY IN AGREEMENT WITH RECORD I HAVE ACCEPTED IT AS DEFINING THE WEST LINE OF PARCEL 1 OF SAID SURVEY. INVESTIGATING THE RECORD LOCATION OF THE WEST ANGLE POINT OF SAID PARCEL 1, I DISCOVERED A NAIL AND TAG R.E. 292 AND AM CONVINCED THAT ANOTHER MONUMENT EXISTED AT SOME TIME I HAVE REESTABLISHED THE WEST ANGLE POINT OF PARCEL 1 (3 RS. 92) AT THE RECORD DISTANCE FROM THE CALLED FOR T BOLT ALONG THE PROLONGATION OF THE MONUMENTED LINE.
2. THE NORTH AND EAST LINE OF PARCEL 2 (2 PM 84) ARE ESTABLISHED AS PARALLEL AND PERPENDICULAR TO THE SOUTH LINE OF PARCEL 2 (3 RS 92) AS DEFINED BY THE RECOVERED MONUMENTS SHOWN.


