THE FOLLOWING TERMS AND CONDITIONS ARE REQUIRED AS PART OF THIS AGREEMENT. DO NOT SIGN UNTIL YOU HAVE READ ALL IN IT'S ENTIRETY.

- 1.) California Food & Agricultural Code, Sections 31750 & 31751 state no dog, cat, kitten or puppy may be sold or given away by any public shelter that is not spayed or neutered UNLESS the shelter is given a deposit towards that animal's spay or neuter. The required deposit for kittens is \$50.00, the deposit for puppies is \$75.00.  
**ADULT cats or dogs will be taken to a veterinarian by Plumas County Animal Control and SPAYED OR NEUTERED AND VACCINATED FOR RABIES. The adopter can then pick up the cat or dog and pay any accrued fees.**  
**Puppies and kittens MUST BE SPAYED OR .NEUTERED by the age of 5 months. License fees will be paid at time of adoption, unless the dog is younger than 4 months. Upon receiving proof of vaccination, license will be mailed to the owner.**
- 2.) Deposits for spay or neuter are refundable IF THE ABOVE TIMES AS SPECIFIED are met.
- 3.) **FAILURE to meet the above conditions will result in DEPOSIT FORFEITURE and may make you liable for legal action. Also adoption will be terminated and ownership will revert back to. the Plumas County Animal Control and the animal will be impounded.**
- 4.) All monies from deposits in forfeiture will be used for other purposes AS PRESCRIBED .BY LAW.
- 5.) In addition to the above deposit a non-refundable adoption-fee of \$10.00 is charged for each animal.
- 6.) **ALL COSTS** incurred to meet these conditions in excess of the refundable deposit ARE THE SOLE OBLIGATION of the adopter.
- 7.) Plumas County Animal Shelter makes no claims, representations or assurance as to this animals health, behavior or temperament and that you are taking full responsibility, present and future, for any damages to person or property caused by, or from ownership, of this animal.
- 8.) **Adult dogs older than 4 months must be given a Rabies vaccination and licensed within 10 days of adoption.**
- 9.) **Puppies must be vaccinated for Rabies and licensed by the age of 4 months.**
- 10.) **Failure to meet any of the conditions listed under (1), (j), (8) or (9) are violations of State or County animal control laws for which a "Notice to Appear" before the Judicial Court within the district as charged will be issued.**
- 11.) **Any animal purchased from animal control center by any person shall be restored to the owner upon proof of ownership if such animal is reclaimed within thirty (30) days. The purchaser shall be reimbursed by the owner for the actual expenses incurred by adoptee.**
