The purpose of this Record of Survey is to show the correct monumentation of the Lands of Taylor per Deed Ref. 2017-0001017.

This area of Sec. 35 T.27N., R.9E. has had many (approximately 10) Record of Surveys or Parcel Maps completed within it.

16 RS 68-71 is an opinion per Mr. Snow of where the Taylor property should be monumented. His opinion is based on a Forest Service survey filed in 13 RS 21-22. 13 RS 21-22 uses Grid Bearings and Distances.

On 16 RS 68, under Corner Notes, the set note states "Accepted found corner per (R1) measured the line between the NW S35 & N 1/4 S35. I found it to be within 0.03' (1cm or G.P.S. accuracy) the (R1) measurement therefore I accepted (R1)."

(R1) is referenced as 13 RS 22.

16 RS 68-71 does not indicate that it is using Grid Bearings and Distances. 16 RS 68-71 shows several monuments that were set using Ground Distances from older maps. A problem arises with 16 RS 68-71 when both Grid and Ground Distances are used.

The survey on this map is my opinion showing the correct monumentation of the Lands of Taylor using record monuments and measurements.

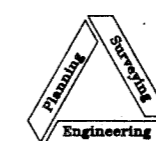
