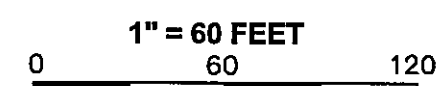


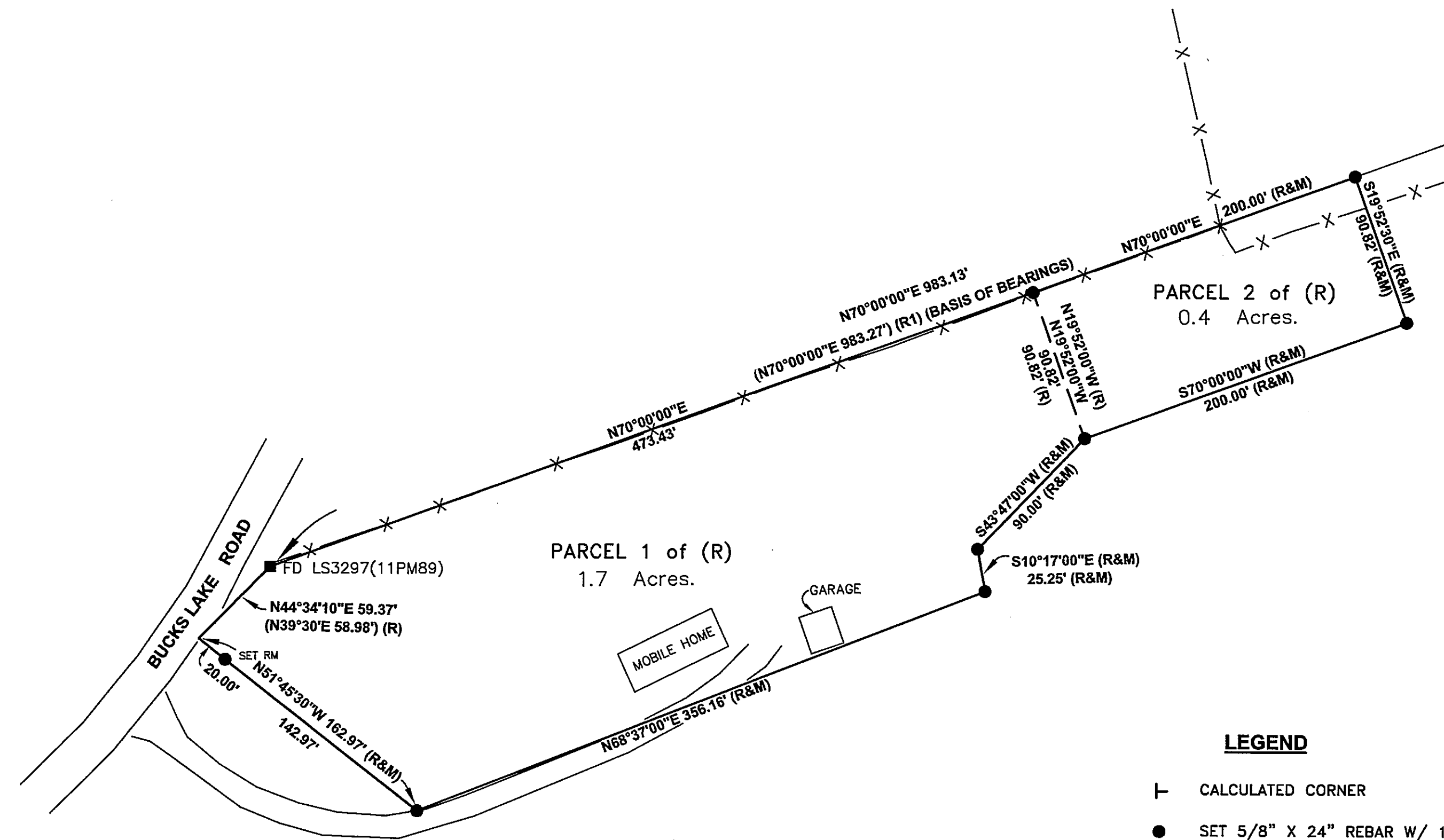
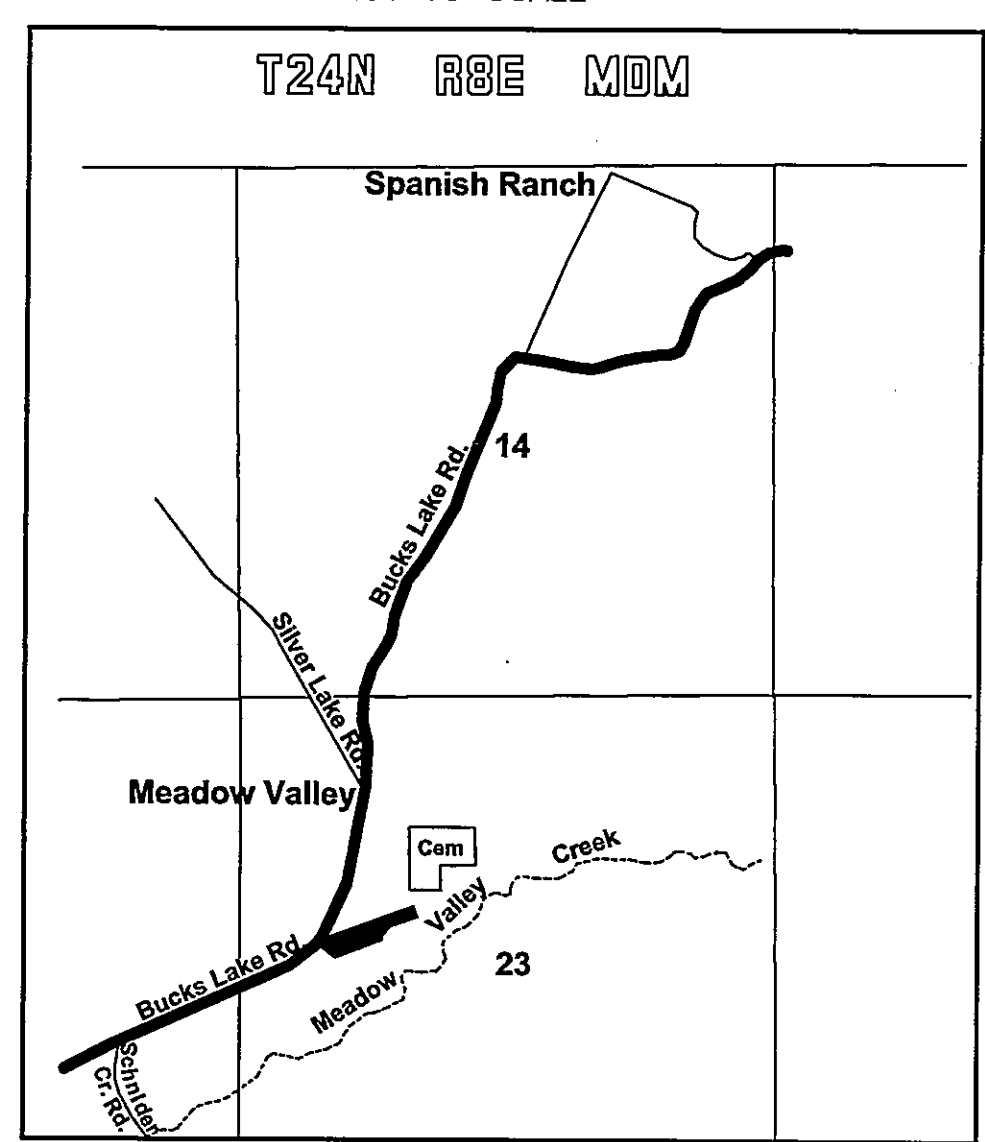

BASIS OF BEARINGS

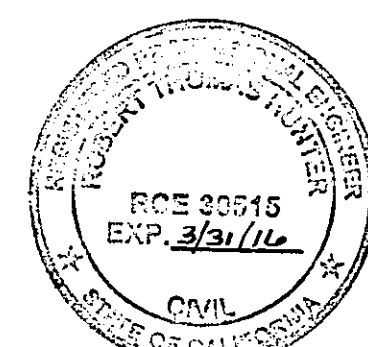
