

### **PURPOSE OF SURVEY**

THE PURPOSE OF THIS SURVEY IS TO MONUMENT THE CONSOLIDATED EXTERIOR BOUNDARIES OF PARCELS 1, 2, 3 AND 4 OF THE GRANT DEED FILED FOR RECORD AT DOCUMENT NO. 2020-0004304 IN THE OFFICIAL RECORDS OF PLUMAS COUNTY IN ACCORDANCE WITH THE CALIFORNIA PROFESSIONAL LAND SURVEYORS ACT, SECTIONS 8762 THROUGH 8764.5. NO NEW PARCELS HAVE BEEN CREATED AS A RESULT OF THIS SURVEY.

### **BASIS OF BEARINGS**

BEARINGS FOR THIS SURVEY ARE BASED UPON THE CALIFORNIA STATE PLANE COORDINATE SYSTEM, ZONE 1, NAD83(94), DERIVED FROM REAL TIME KINEMATIC GPS OBSERVATIONS, OBSERVED OCTOBER 10, 2018, USING A SURVEY GRADE DUAL FREQUENCY GPS RECEIVER FROM NGS STATION "HPGN D CA 03 MO" WITH A COMBINED SCALE FACTOR OF 0.99982083. FOR REFERENCE TO THIS SURVEY, THE SOUTH LINE OF THE SW 1/4 OF SECTION 21, AS SHOWN HEREON, IS THE BASIS OF BEARINGS. (N 88°56'14" E)

- 1. ALL DIMENSIONS ARE HORIZONTAL GROUND DISTANCES, AS MEASURED IN THE FIELD, UNLESS OTHERWISE INDICATED.


