violations 27. Food not properly separated in two back fridges - uncooked/raw meat must be stored below ready to eat foods such as vegetables

34. Dishwasher not sanitizing at time of inspection, until repaired all dishes must be cleaned using 3-compartment sink with wash → rinse → sanitize procedure.
Manual sanitize w/ 100ppm chlorine/bleach

33. Clean & Sanitize non food contact surfaces - pay special attention to hard to reach areas such as under and around equipment.
