Restrictive Covenant Modification

California Government Code Section 12956 authorizes a person who holds an ownership interest of record in property that is the subject of a racially or otherwise unlawfully restrictive covenant to record a Restrictive Covenant Modification document to have the illegal language redacted.

THE PROCESS TO BE FOLLOWED TO RECORD A RESTRICTIVE COVENANT MODIFICATION IS OUTLINED BELOW:

1. Property owner submits to the Plumas County Recorder:
 - Completed Restrictive Covenant Modification form with their signatures notarized.
 - A complete copy of original Declaration of Covenants, Conditions and Restrictions (CC&R) containing the unlawfully restrictive covenant language with the unlawfully restrictive covenant language stricken.
2. Both documents will be submitted to County Counsel to determine whether the restrictive covenant is unlawfully discriminatory. County Counsel will notify our office with their determination within 5 business days.
3. If County Counsel agrees that the language is discriminatory, they will sign the Restrictive Covenant Modification.
4. Once signed by County Counsel, the Restrictive Covenant Modification is recorded for the \$75.00 SB2 Housing fee. Local recording fees are waived.
5. Regular copy fees apply \$3.00 per page. Conformed copy at no fee if copy of document is presented.

Typically, you receive a copy of your property's CC&R's from the title company when you purchase your home. If you recently purchased a home and did not receive a copy of your CC&R's, contact your title company or HOA.
