Priorities may change depending on other County Capital Improvement projects or request for accommodation from the disabled community. Otherwise it is important to follow the priorities established. A percentage of the yearly budget shall be designated for sidewalk-street crossings improvements, and the remainder should be distributed according to the Transition Plan Schedule.
