INSTRUCTIONS:

A. Body Art Operator

If you are applying to register as a Body Art Practitioner (tattoo artist, body piercer, or permanent cosmetician) please do the following:

- 1. Complete the Body Art Facility and Practitioner Registration
- 2. Attach proof of Hepatitis B vaccination or, if you are in the process of completing the series, please check the "certification of completed vaccination" box and attach a copy of associated medical documentation (e.g. vaccination card).

If you are declining the Hepatitis B vaccination series, read and sign the Hepatitis B Declination Statement and submit it with the application document.

- 3. Provide copy of your Blood Borne Pathogen Training certificate
- 4. Pay required fees (call for current fees) \$ 186.00

B. Body Art Facility

If you are applying to permit a new Body Art Facility (Tattoo Shop, Body Piercing Shop, Permanent Cosmetic Shop) please do the following:

- 1. Complete the Body Art Facility and Practitioner Registration
- 2. Complete Plan Check List (Parts A & B)
- 3. Pay required fees (call for current fees)

Applicants for a new Body Art Facility should allow adequate time to complete **Parts A & B of the Facility Plan Check List** prior to the facility's anticipated opening. Body art services cannot be provided until the requirements on this check list is approved and completed.

Please be aware that city jurisdictions may also need separate time considerations for compliance with City of Portola business and zoning requirements.

PLAN CHECK LIST for New Body Art Facility

This plan check list is provided as a guidance to assist the facility owner/ operator to open a body art shop that will meet public health and safety requirements established by California's Safe Body Art Act (AB 300). The applicant must complete Parts A and B prior to providing services to the public.

Part A. To be submitted as part of the application package:

- 1. Schematic or drawing of the shop showing the location of the procedure area, workstations, handwashing sinks, bathroom, and the clean room (along with the placement of the sonicator and autoclave); schematic must identify materials used on the floors, cabinets, counters, etc...(concrete, laminate, tile, etc...).
- 2. Copy of proposed Infection Prevention and Control Plan for the shop
- 3. List of Body Art Operators anticipated to work in the shop
- 4. If applicable Proof of compliance with City of Portola business and zoning requirements
- *Items 5-7 are only applicable for facilities utilizing an autoclave
 - 5. Spore test result showing the autoclave to be used is operational. Spore test must be recent (less than 30 days) and sampled according to manufacturer's recommendation for testing for non-use, re-conditioning, repair, or handling for relocation.
 - 6. Copy of the service agreement with the spore testing laboratory.
 - 7. Copy of the manufacture's specification for the autoclave

Part B. An inspection of the facility will be performed prior to the business being open. The facility must have the following in place within the shop before services can be provided:

- 1. Client consent forms
- 2. Written aftercare instructions
- 3. Hot and cold running water
- 4. Operational hand-washing sink
- 5. Clean room set-up (if applicable)
- 6. Single use supplies (tattoo equipment, needles, ink wells, gloves, paper towels, seran wrap or other coverings for chairs, workstations, etc...)
- 7. Cleaning and disinfecting supplies
- 8. Sharps container
- 9. Soap and single use towels at hand washing sink for workstation
- 10. Garbage cans
- 11. Availability of public restroom with soap and single use towels
- 12. Proof of business license

Applicants for a new Body Art Facility should allow adequate time to complete **Parts A** & **B of the Plan Check List** prior to the facility's anticipated opening. Body art services cannot be provided until the requirements on this check list is approved and completed.

Please be aware that the City of Portola may require separate time considerations to review applicable business and zoning requirements.

Body Art Facility Infection Prevention And Control Plan Guideline

In accordance with the California Health and Safety Code, Section 119313, a body art facility shall maintain and follow a written Infection Prevention and Control Plan, provided by the owner or established by the practitioners, specifying procedures to achieve compliance with the Safe Body Art Act. A copy of the Infection Prevention and Control Plan shall be filed with the Local Enforcement Agency and a copy maintained in the body art facility.

The body art facility owner shall provide onsite training on the facility's Infection Prevention and Control Plan to the body art practitioners and employees or individuals involved with decontamination and sterilization procedures.

Training shall be provided when tasks where occupational exposures may occur are initially assigned, anytime there are changes in the procedures or tasks and when new technology is adopted for use in the body art facility, but not less than once each year.

Records of training shall be maintained on-site for three years.

The Infection Prevention and Control Plan shall be maintained current and updated whenever there are changes to any of the procedures or tasks listed and when new technology is adopted for use in the facility.

Bloodborne Pathogen Training

A person shall not perform body art if he or she is not registered with the local enforcement agency. As a condition of registration, the applicant shall provide evidence of completion of OSHA Bloodborne Pathogen Training consistent with Section 119307 and pursuant to paragraph (2) of subdivision (g) of Section 5193 of Title 8 of the California Code of Regulations or its successor.

Below are several on-line options for OSHA Bloodborne Pathogen Training providers. If the applicant has obtained or desires to obtain the required training from an additional provider, the applicant shall ensure that any Bloodborne Pathogen Training is OSHA compliant which meets all criteria pursuant to Section 119307 and is approved by Plumas County Environmental Health.
